Annual School Health Services SUMMARY REPORT 2015 –2016

The Annual School Health Services Report (ASHSR) highlights the data submitted to the New Mexico Public Education Department by 86 of 89 (97%) school districts (inclusive of local charter schools). This report provides a snapshot of the health care needs of New Mexico students and the health services provided by school nursing staff during the 2015-2016 school year. The New Mexico Department of Health and the New Mexico Public Education Department have worked collaboratively to create this summary report.

- Our school nurses provide a valuable service and are absolutely essential in ensuring the health and wellness of our students and staff. Through disease prevention and management, our nurses are improving our attendance and student performance in addition to freeing up time for administrators as they complete necessary tasks such as screenings, verification of immunizations, and administration of specialized services (medications, insulin pumps, ventilators, tube feedings) and provide professional input for school policies and programs. Furthermore, our nurses are providing direct access and significant assistance and education to families who struggle to navigate the health care system.




School Nurse Staffing in New Mexico

- **510** licensed school nurses, assisted by **11** LPN'S and **408** health assistants, provided care for **322,538** students on **803** public school campuses.
- The minimum recommended nurse to student ratio of 1:750 is for the general student population. In the case of students who may require daily nursing services, this ratio is reduced to 1:225. This recommended ratio continues to decrease as the complexity of student health care needs increases.
- As of the 2015-2016 school year, 20 out of 86 (approximately 23%) districts reporting have less than 1.0 full time professional school RN to lead the school health team.

Students with a Medical Diagnosis

- **49**% of NM students had an identified medical diagnosis (N=162,604).
- Top 3 medical diagnoses were: Allergic disorders, Asthma, and ADD/ADHD.
- **6,958** students had a mental health diagnosis.
- **701** students had a pregnancy diagnosis.
- 1,099 students had a Diabetes diagnosis (Type I=781, Type II=318).



Medically Complex Procedures

- **8,611** of NM students required a medically complex procedure.
- Care for asthma and diabetes accounted for 90% of the medically complex procedures.
- Additional procedures are often time intensive and may require 1:1 nursing care.

Asthma care

- Oxygen saturation (38.0%)
- Peak flow measurement (25.8%)
- Nebulizer treatment (9.0%)

Diabetes care


- Glucose monitoring/keytones (8.8%)
- Carbohydrate counting (8.2%)

Additional procedures

- NG/G tube care/feeding/meds (2.5%)
- Wound care (2.3%)
- Other medical procedures (2.1%)
- Oxygen delivery (1.1%)
- Catheterization (0.8%)Ostomy care (0.5%)
- Suctioning (0.5%)
- IV/Hep flush (0.1%)
- Ventilator care (0.1%)

*Medically complex procedures are those that require professional nursing/medical assistance.

Top Three Diagnoses by School Year





Student Visits to Health Office

- There were just under **2.1 million visits** to school health offices.
- Top 3 reasons for visits were: Acute illness (34%), Chronic conditions (25%), and Injury (17%).
- **74,750** students were referred to outside providers for follow up care.
- With their health needs met, 91% of students returned to class.


Top 3 Reasons for Visits to Health Office and Percent Referred to Outside Providers

Prescription Medications

- **31,847** students had prescription medications available for administration at school.
- Top 3 prescription medications available were asthma medications (39%), epinephrine (22%), and allergy medications (9%).
- 5,117 emergency medications were administered by school nurses.



Student Screenings, Assessments and Referrals

- A total of 304,660 student screenings in the areas of hearing, vision, special education referral process, substance abuse and depression were completed.
- Of those screened for depression, **42.1** % were referred to outside providers for evaluation and treatment.
- **13,339** Individualized Education Program, Student Assistance Team and Section 504 meetings were attended by the school nurse.
- **15,980** Individualized Health Care Plans, Emergency Care Plans, and Section 504 Plans were developed by the school nurse..
