The Special Education Bureau (SEB) of the New Mexico Public Education Department (PED) conducts meetings periodically with Special Education Directors from each Local Educational Agency (LEA), Regional Educational Cooperatives (RECs) and other Stakeholders. These meetings give LEAs, RECs and Stakeholders the opportunity to provide input regarding the distribution of funds based on current trends and state-wide performance standards.

A Stakeholders' meeting was held in Santa Fe, March 2017 to provide an opportunity for stakeholders to submit their input regarding the distribution of funds among the state-level activities. Representatives from PED, LEAs, RECs, contractors from higher education Institutions and parent organizations attended the meeting. The proposed budget was shared with attendees. Stakeholders were allowed an opportunity to provide recommendations that relate to PED's Strategic Plan.

On March 10, 2017, SEB sent out a Public Notice to notify LEAs, RECs and other Stakeholders that PED will be accepting public comments for 30 days, beginning March 10, 2017, through April 9, 2017, regarding the distribution of funds among the state-level activities. The State Application, including the proposed budget, was posted on SEB's website for 60 days, from March 10, 2017, through May 9, 2017. LEAs, RECs, Stakeholders and the general public, including individuals with disabilities and parents of children with disabilities, are given the opportunity to provide comments regarding the proposed budget. All public comments are then compiled and taken into consideration when PED finalizes the budget and submits the State Application.

¹ Each State may reserve for each fiscal year not more than the maximum amount the State was eligible to reserve for State administration under this section for fiscal year 2004 or \$800,000 (adjusted in accordance with 20 U.S.C. 1411(e)(1)(B)), whichever is greater; and each outlying area may reserve for each fiscal year not more than 5 percent of the amount the outlying area receives under 20 U.S.C. 1411(b)(1) for the fiscal year or \$35,000, whichever is greater.
