III. Executive Summary and Proposed Motions:

Request and Rationale

Taos International Charter School is requesting to amend its Charter to alter the length of its school year. The current Charter designates the school year at Taos International to be 180 days long. The School seeks to change their schedule so the regular school year will be 153 days.

The school indicates the rationale for its request is to allow the school to move forward with an improvement plan that will assist the school staff in exceeding students' needs and improving the letter grade the school currently holds. The school is planning on using their new calendar as an opportunity to provide for professional development for its teachers.

The PEC approved Taos International Charter School amendment request to <u>extend their school day</u> at the June, 2016 PEC Meeting. However, the school had combined both the length of the school day and a change to the number of instructional days into one amendment and the PEC informed the school should have separated these into two amendments.

School History

The school opened its doors for the 2014-2015 school year serving only the following grades: Kindergarten, 1, and 6. During the 2015-16 School, the school served students in grades Kindergarten, 1, 2, 6 and 7.

This Dual Language/International Baccalaureate K-8 free public state chartered school, came into existence after a group of founders expressed their shared concerns about students who did not excel in traditional educational settings. In addition, not all students who began a dual language program in the public school system were able to continue in upper elementary grades due to limited space, and no dual language program exists locally for sixth grade students at the middle school level. Students had to abandon their dual language studies in the middle school grades.

Taos International School will serve the diverse population of Taos and will be the first school in this area to offer the International

Baccalaureate's Primary and Middle Years Programmes. Taos International Charter School charter was approved by the Public Education Commission on June 6, 2013.

Analysis of Amendment Request

The school's contract indicates the following information in the Material Terms of its current (2014) Contract:




Under their current contract, the school's current number of instructional days is 180 days. The school is seeking to reduce their number of instructional days to 153 days. This change will reduce the number of instructional hours by 44 hours.







School Performance

In 2014-15 Taos International Charter School's school grade was a D.

The table below shows a comparison of the school's state assessment proficiency data to the statewide data and the Taos Municipal School District data. Taos International School Request for Calendar Change

The rational for Taos International School requesting to change the 2016-2017 school year calendar are as follows:

The Safety and Stability of our Students

According to federal data, violent juvenile crimes occur most frequently in the hours immediately following the end of a school day. Statistics show that between 3:00 and 5:00 PM can be risky for many students as they are often alone and unsupervised. In our community of Taos, a majority of our families work from 8:00-5:00. Parents/Guardians have expressed there is difficulty with our current schedule. Our schedule consists of an 8:30 to 3:30 school day followed by a 3:30 to 4:30 after school program. In many instances children will be dropped off early in the office or staff waits till five or later for students to be picked up. As a famous quote states "it takes a community to raise a child," we at Taos International School think highly of the concerns and safety of our families and students. Therefore, our proposed calendar change, with school hours from 8:00 to 4:00, with early drop off at 7:45 and after school program from 4:00 to 5:00 will accommodate our families and most importantly, our students, with a safe learning and caring environment. These hours will also meet our instructional hours with a 7.5 hour day, four days a week.

Change of Calendar

Taos international Schools, is proposing going from 8:00 AM to 4:00 PM four days a week and 8:00 AM to 1:30 PM on Fridays. One Friday a month is put aside for professional development and staff collaboration. We are hoping this calendar change will reduce student absences. Because Taos is a rural community, students often have to travel to Santa Fe or Albuquerque for Dr. and dental appointments. Friday's 1:30 dismissal and one Friday a month with no school, for students, will allow them to travel out of town for appointments without affecting school attendance. We have also observed in the past years that we have had a significant amount of students absent once the other schools have let out for summer vacation and we are still in session. It has been brought to our attention that summer sports and camps start up as soon as the other schools let out for summer vacation. Because Taos International School is still in session, this results in student absence to attend these sports and camps. With our 153 day calendar, Taos International School will be more uniform with the other schools in our community. This will cut down on students being absent at the end of the year.

RTI and Study Hall

With our current calendar change we will provide differentiated instruction for one hour four days a week. Two days we will be working on math and two days we will be working on reading. All Kindergarten through Third grade will be grouped in small groups according to their IDEL scores. Six through eighth grade will be grouped according to their MAP scores for reading. All students Kindergarten through eighth grade will be grouped for math according to their MAP scores. Our goal as a school with the RTI program is to push all students to move up levels, prepare students for PARCC, improve our school grade and ultimately prepare our students to be successful in a global society.

Also, in our proposed calendar we have built in a study hall period for all students to work on homework and get caught up on projects and work on the computer. Our implementation of study hall will allow students to go home stress free with out homework, allowing parents and children to spend quality time together.

Staff Collaboration and Professional Development

Our current calendar change will allow for collaboration and professional development during our Friday afternoons. and Full Day Fridays once a month. During this time we will reflect on the mission, goals and objectives of Taos International School which include International Baccalaureate requirements, one-way language immersion education, and core content standards training. The school will actively seek resources for improvement of professional development opportunities for all staff members through all means available. The school will actively seek funds for improvement of teaching and learning through high quality professional development activities in core academic subjects through all means available, including but not limited to grants, operational funds, and professional development provided free of charge. At Taos International School, weekly group planning time will give teachers formal and informal opportunities to review, revise, propose curriculum activities and develop the teamwork critical to the success of all the educational program and ultimately improve our school grade at Taos International School.





School Growth

School growth compares the students enrolled in the current year to the same students from prior years. Unlike Current Standing, School Growth accounts for improvement of all students, not just those reaching proficient.

Growth in proficiency is calculated with Value Added Modeling (VAM), which accounts for the school's size, student mobility, and prior student performance. Details of VAM can be found in the PED's School Grading Technical Guide at http://webapp2.ped.state.nm.us/SchoolData/SchoolGrading.aspx

School growth is expressed as a score that can be both negative and positive. When it is positive the school performed better than was expected relative to its peers with the same size, mobility, and prior student performance.

Student Growth

Just like schools, individual student achievement is expected to improve over time. Student growth is shown as a value added score (VAS) that accounts for all students in each group for up to 3 years. Student groups are further divided into highest and lowest performing subgroups. Every student's prior test scores are used to estimate how they should perform today.

- Above 0 means that the group, in general, scored higher than expected. This is an exciting finding when students
 are below the proficiency line, because they are closing the achievement gap and catching up to their higher-performing
 classmates.
- Near 0 means that the group scored about as expected compared to their academic peers. While some students may have
 performed better than anticipated (positive growth), they were equally balanced by students that did poorer (negative
 growth).
- Below 0 means that the group performed below expectations and students are losing ground when compared to their peers.
