What is PARCC?

The Partnership for Assessment of Readiness for College and Careers (PARCC) is a consortium featuring eight states, the District of Columbia, and the Bureau of Indian Education, that work to create and deploy a standard set of K–12 assessments in Mathematics and English, based on the Common Core State Standards.

PARCC Consortium Membership History

2010 PARCC Consortium of 24 states and the District of Columbia is established.

2014 14 states plus the District of Columbia remained in the PARCC consortium.

2017 8 states plus the District of Columbia remain in the PARCC consortium.

Active PARCC Consortium Members

Bureau of Indian Affairs, Colorado, the District of Columbia, Illinois*, Louisiana*, Maryland, Massachusetts, New Jersey, New Mexico, and Rhode Island.

* Illinois uses for grades 3-8 only, SAT for High School

** Louisiana uses a hybrid of PARCC/state tests

English Language Arts

- ✘ On average EPS students increased ELA performance by **2.17** percentage points from 16.7 to 18.9%.
- ✘ On average NM students statewide increased ELA performance by **0.66** percentage points from 27.9 to 28.56%.
- ✘ On average EPS scored **9.66** percentage points below NM statewide average.
- ✘ **Goal:** EPS students will increase by **10** percentage points to meet or exceed NM statewide ELA performance for the 2017-2018 SY.

Mathematics

- ✘ On average EPS students **decreased** Math performance by **1.1** percentage points from 9.97 to 8.91%.
- ✘ On average NM students statewide **decreased** Math performance by **0.6** percentage points from 19.6 to 19.0%.
- ✘ On average EPS scored **10.09** percentage points **below** NM statewide average.
- ✘ **Goal:** EPS students will **increase** by **10** percentage points to meet or exceed NM statewide Math performance for the 2017-2018 SY.
