¹Beginning with the 1997-98 school year, funding for A-level and B-level special education services will be determined on the basis of membership rather than program FTE. Prior to 1997-98, students receiving C and D level special education services were counted apart from the grade level counts. Beginning 1997-98, all students are counted at grade level (Laws of 1997, Chapter 40).

²Because of the funding formula revisions, which went into effect on July 1, 1999 (Laws of 1999, Chapter 275, Section 1), membership for 1998-1999 was used to determine the funding for 1999-2000 and the average of the prior year's 40th, 80th and 120th day membership was used to determine funding beginning in 2000-2001, and the average of the prior year's 40th, 80th, and 120th day membership was used to determine funding beginning 2000-2001 and fiscal years thereafter.
