7. Vision/Mission statement. (2-3 sentences)				
Santa Fe Classical Academy will provide a rigorous, content-rich educational program to develop the academic potential of every student utilizing curricula not currently available in northern New Mexico for grades K-12. The Core Knowledge Sequence, to be used in grades K-8, has been proven through numerous studies and in a wide variety of locations to improve test scores in all included subject areas and lessen performance gaps between white and minority students, and affluent and disadvantaged students. Our high school will build upon the Core knowledge Sequence through a rigorous Great Books-based college preparatory curriculum with clearly articulated building blocks of world history; the masterworks will study our core curriculum, which will teach the essential building blocks of world history; the masterworks of literature; a globally proven math curriculum; all the major sciences including geology and geography; history of art and music; Latin and mastery of one to two modern foreign languages.				

8. Student body to be served, including key demographic data and targeted geographical area of the proposed school. The Santa Fe Public Schools (SFPS) student population of 12,591 students is 77% Hispanic, 18% Anglo and 3% Native American, according to the Santa Fe Public Schools Accountability Report 2009-2010. Approximately half of all students are English language learners, and 63% qualify for free or reduced price lunches. While nationally 70% of students entering 9th grade will graduate on time with their peers, among Hispanics this figure is closer to

50%. Among SFPS schools struggling to improve such statistics, very few have made Adequate Yearly Progress. Many eyes focus on those students who fail to meet expected norms. To ensure that all students meet standards, teachers often level their curriculum so that the at-risk population can complete the work. Thus, students with academic aspirations, and those with high levels of academic success, are not always challenged. SFCA will provide a rigorous curriculum ideal for students willing to work to exceed existing standards – whether to gain entry to or succeed in college, or simply to receive a top-notch primary and secondary education.

Santa Fe Classical Academy will serve students and their families who seek a curriculum of academic rigor in an intimate environment. Students and their families will be asked to commit the time and effort necessary to meet high learning expectations. Core Knowledge has been shown to lessen the performance gap between affluent white and minority students, a central issue in northern New Mexico. It also has raised test scores well above state averages in many schools with diverse populations, including schools characterized by large populations of Hispanic and disadvantaged ELL. Our goal is that all students, regardless of ethnicity or socio-economic standing, will be given the opportunity to learn from exciting proven curricula which are not available elsewhere in this region.

9. Evidence and assessment of a community need for a school of this nature: Detail any objective surveys or other measures of local demand for the proposed educational program.

As previously stated, test scores in the district indicate that Santa Fe schools are in need of educational innovation. Core Knowledge is a curriculum which has been extensively studied, and has been proven to increase test scores for virtually all student populations and in extremely varied demographic settings. This curriculum is not currently offered in northern New Mexico. Thus, it can play an important role in the effort to improve levels of educational achievement in this district.

Also, there is a huge demand for charter alternatives in this district. Existing charter schools report enormous lottery lists each year, up to 800 lottery applicants each year in the case of the two middle/high school charters. This suggests area families are hungry for educational alternatives, and would support a new charter.

10. Key innovative, unique and/or programmatic features the school will implement in order to accomplish its vision and mission (non-traditional school year, longer school day, partner organizations, etc.)

The school will utilize a traditional school year – approximately from Labor Day to Memorial Day – and a regular school day of seven hours. This school will be unique in offering a curriculum – Core Knowledge in K-8, extended through a modified Great Books program in 9-12 – which is unavailable elsewhere in central to northern New Mexico.

11. How the school will be more effective than the schools currently serving the targeted student population, and/or plans to improve student achievement and exceed the academic performance of existing public schools in the targeted service area and any data you have to support this assumption.

This school will utilize a curriculum proven to increase test scores in diverse populations and settings. A large body of data shows that students at Core Knowledge schools routinely exceed state test score averages by large margins. Our application provides detailed information on the proven ability of Core Knowledge to improve test scores.
