

PART D—Petitions of Support

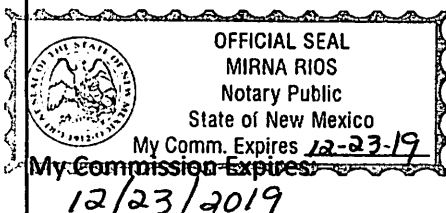
