**BILL SUMMARY**

Synopsis:

House Bill 340 makes an appropriation of \$150.0 thousand from the general fund to the library services program of the Cultural Affairs Department for the FY2020. These funds will be available to support schools participating in the National History Day program.

**FISCAL IMPLICATIONS**

This bill appropriates \$150.0 thousand from the general fund to the library services program of the Cultural Affairs Departments. Any remaining balances at the end of FY20 will be reverted to the general fund.

**SIGNIFICANT ISSUES**

Based on 2016-2017 data, 24 teachers at 24 various schools, with a total of 213 students across New Mexico participated in the National History Day Program.
