Synopsis: House Bill 351 amends section 12-5-10 NMSA 1978 to allow for the recognition of “Guadalupe Hidalgo treaty day” to provide that in a year in which February 2 is a Saturday or Sunday, official observance of Guadalupe Hidalgo treaty day shall be on the immediately following Monday.
