Embargo Data Review of Spring 2019 Assessment Results

The Public Education Department (PED) is pleased to provide a local preview period of your Spring 2019 student achievement result. The results will be posted in the Secure Online Assessment Portal (SOAP) at https://soap.ped.state.nm.us/ beginning today at 12:00 p.m. for your review. Results are unmasked and contain student results for as few as one student. This embargo period allows districts and charter schools to review their data for discrepancies.

Following this embargo period, the PED will provide complete and publicly accessible data sets on **July 26th**, at 3:00 p.m. Public release of <u>masked</u> results will be compliant with all laws protecting individual student privacy.

Statewide Transition Assessment Performance

This was the first year of using a shorter version of the blueprints, and it is not uncommon to see some variability whenever such changes are made to an assessment program. The baseline results from the transition assessment produced comparable results to the traditional PARCC assessment, with both English language arts (ELA) and mathematics proficiencies about 1.5 percentage points different from PARCC proficiencies. The minor fluctuations in the statewide ELA and math results are well within normal variation, and other states transitioning away from the PARCC assessment experienced similar results. This level of comparability will help to track academic progress over time.

Educators and other stakeholders should always focus on multi-year trends to understand how educational programs are working and what improvements may be necessary. We applied the efforts undertaken by our educators and schools to maintain high-quality instruction aligned to our adopted standards during this transition year.

New Mexico hopes to see improvements in the state's summative assessment framework in the next few years, as the assessment systems shifts to reflect the feedback and guidance from our community engagement conversations, the Student Success Task Force, and the Assessment and Accountability Advisory Committee. Our current procurement aims to provide

- **culturally relevant, custom developed assessments** in grades 3–8 without increasing testing time and while maintaining comparability;
- a college entrance exam for all students at grade 11;
- a more **balanced approached to measuring student learning** that encourages the use of local classroom and district level assessments; and
- assessment literacy for multiple stakeholders.

As recommended by the task force, the Spring 2020 math and ELA assessment in grades 3–8 will use the same blueprint as Spring 2019, with the addition of custom-developed field test items.
