| <p>EL Student 3-5 Years in a U.S. school (at least 3 full academic years but less than 5 full years)</p> <p>The student must participate in ESSA required testing in one of the following options.</p> | <p>Take SAT with or without supports.*</p> <p>EL SAT/PSAT allowed supports* include: having test directions provided in Spanish (other languages included); use of approved word-to-word glossaries; and 50% extended time.</p> <p>Students will receive a college (SAT) or scholarship reportable score.</p> | <p>This option requires PED approval; LEAs must submit a <i>Waiver of Testing In English</i> form.</p> <p>Take SAT/PSAT Math only (EL SAT/PSAT allowed supports* apply as well as state allowed accommodations) and Spanish Reading SBA for the English language arts testing requirement.</p> <p>Not a college or scholarship reportable score because student is taking only the math section.</p> | <p>Although students in EL status participate in ACCESS, the score cannot be substituted for ELA.</p> |
| <p>5 or more full academic years in a U.S. school</p> | <p>The student must participate in SAT/PSAT in English; no waiver granted</p> | | |
