MEMORANDUM

TO: Superintendents and Licensed School Business Officials

**RE: FINAL ADJUSTMENT-STATE EQUALIZATION GUARANTEE
** ACTION REQUIRED BY JUNE 8, 2020 ****

Section 22-8-25(G), NMSA 1978 provides:

The state equalization guarantee distribution shall be distributed prior to June 30 of each fiscal year . The calculation shall be based on the local and federal revenues specified in this section received from June 1 of the previous fiscal year through May 31 of the fiscal year for which the state equalization is being computed. In the event that a school district or charter school has received more state equalization guarantee funds than its entitlement, a refund shall be made by the school district or charter school to the state general fund.

Attachment (1) is a worksheet entitled "2018-2019 Charter School Receipts and Distributions" indicating the 2019-2020 final funded program units, 2019-2020 funded program cost, and actual Operational Impact Aid received July 2019 through May 2020. Also included are the total June 2019 Impact Aid credits as reported to PED with the June 2019 end of year reports from the 930F form, and the amount of State Equalization Guarantee (SEG) distributed July 2019 through May 2020.

Please verify this information, as it will be needed to complete the enclosed reports.

Attachment (2) is the Final Adjustment for 2019-2020 State Equalization Distribution and Attachment (3) is the Operational Portion of Receipts Report. These forms are to be completed and returned to the School Budget and Finance Analysis Bureau (SBFAB) as soon as possible after the close of May, but no later than **JUNE 8, 2020**. The reports will be reconciled and final distribution of SEG will be made on or before a target date of **JUNE 19, 2020**.

The distribution is dependent on SBFAB receiving Final SEG Adjustment reports from ALL districts and charter schools before the June 8, 2020 deadline.

Year-End Closeout

Charter schools will be provided instructions for completing the 2019-2020 final reports by June 25, 2020. The deadline for submitting budget adjustment requests (BAR's) for this fiscal year for all funds other than Operational (11000), inclusive of Flowthrough, is **JUNE 1, 2020 close of business. The deadline for the Operational fund's BAR's, including maintenance BAR's, is June 30, 2020.** The deadline for submitting Cash Transfer requests is **JUNE 25, 2020.** A separate memorandum will be issued for closeout requirements for flow-through programs.
