


Yes	Evacuation plan in place that maintains 6 feet social distancing. Dismissal process in place that maintains social distancing.	Located in every hallway and classroom.
Yes	Isolation rooms for symptomatic individuals in place and protocols for students exhibiting symptoms on buses in place.	Isolation rooms located in the front office area, 2 beds available, secondary in nurses office.
Yes	Protocols and signage in place for entrance into the building including temperature other symptoms check.	Located at the front entrance, and throughout the school.
Yes	Signage across the school site that includes expectations for prevention practices: frequently washing hands, avoiding touching eyes, nose, and mouth, wearing masks, staying 6 feet apart and direction of traffic.	The signage is located throughout the school covering all these topics along with pictures, there is no misunderstanding of information being conveyed.
