yes	Evacuation plan in place that maintains 6 feet social distancing. Dismissal process in place that maintains social distancing.	Students are instructed to stand and line up on 6 ft apart. Evacuation plan is set up and designed to keep distancing at a 6 foot length.
Yes	Isolation rooms for symptomatic individuals in place and protocols for students exhibiting symptoms on buses in place.	Isolation rooms are in place for symptomatic individuals and have protocols set in place to the best of my knowledge.
