| Yes  | Isolation rooms for symptomatic individuals in place and protocols for students exhibiting symptoms on buses in place.   | Yes, isolation rooms are in place at each school, and SFPS "Transportation Virus Mitigation Procedures" are provided for buses.  |
| Yes  | Protocols and signage in place for entrance into the building including temperature other symptoms check.  | Signage for entrance into school is provided and consistent for main entrance to all schools for SFPS. There is also a thermometer in each entrance to the school and provided logs for occupants to the school.   |
| Yes  | Signage across the school site that includes expectations for prevention practices: frequently washing hands, avoiding touching eyes, nose, and mouth, wearing masks, staying 6 feet apart and direction of traffic. | Signage in multiple languages as appropriate? Yes, there are multiple signs and typically no more than 100 feet apart in length of hallways. Signs are provided in entrances, lavatories, gyms, hallways, locker rooms, cafeterias, on walls and on floors.  |
