Extra masks are available in the school's office and shall be placed in each of the classrooms in use. There are adult sizes.

Are desks marked for A/B cohorts? Are desks/ students facing one direction? Student's desks are spaced out at least 6ft apart in rooms and are not facing each other. Markers shall be placed on the floors and common areas for distancing.

The bigger tables have been taken out and smaller student desk have been placed in the cafeteria and shall be marked 6 ft apart.

Hand sanitizer is between 60% alcohol. Sanitizer is available inside and outside of all classrooms.

Sanitization logs accesible and posted across the school site? Signage is posted throughtout the facility halls, bathrooms and classrooms.

Air purifiers in place. I was advised that the air purifiers are ordered and on the way .

MERV 10. I was advised the ventilation systems are not compatable with the systems that are in place but the fliters are rated at 11.

Markers are placed throughout school on floors. Students are instructed to stand and line up on 6 ft apart. Evacuation plan is set up and designed to keep distancing at a 6 foot length.

Isolation rooms are in place for symptomatic individuals and have protocols set in place to the best of my knowledge.
