Yes <i>JV</i>	Evacuation plan in place that maintains 6 feet social distancing. Dismissal process in place that maintains social distancing.	Evacuation and safety is priority, Social distancing is secondary once in safe location
Yes <i>JV</i>	Isolation rooms for symptomatic individuals in place and protocols for students exhibiting symptoms on buses in place.	Location will be communicated to all staff members.
Yes <i>JV</i>	Protocols and signage in place for entrance into the building including temperature other symptoms check.	Signs in place, extra masks available All staff are sent a daily health screening
