Yes	Multi-ply cloth masks available and utilized by all staff and students, over the nose and mouth, secure under the chin, snug on face with no gaps.	Extra disposable masks on hand? Double wall cloth masks, face sheilds and disposable medical gowns are available from the front office staff.

Yes	Classrooms and commons areas are set up for 6 feet social distancing with 50% student enrollment in place.	Are desk marked for A/B cohorts? Are desks/students facing one direction. Due to the classrooms square footage we were not able to set up for A & B Cohorts, desks are set up to meet Social Distancing requirements. All students will be facing in one direction. Cleaning and sanitizing will be conducted at the end of each day.

Yes	If applicable, cafeteria (or other congregate feeding area) is set up for 6 feet social distancing and cohorts of students are not mixed.	The Cafeteria has been set up to accommodate Social Distancing requirements, mulitple lunch hours will be required. Staff will regulate and monitor lunch hours to accommodate all classes.

Yes	Hand sanitizer that contains at least 60% alcohol is available across the school and ample cleaning supplies in place. Soap and supplies in bathrooms are ample with reliable running water.	Hand sanitizer is available at the entrance and in each classroom and office, the school site and Maintenance Department have an ample supply on hand. Sanitizer is Betco Advanced Alcohol Foam 62% concentration. All soap dispensers were full, hand dryers are operating and Social Distancing requirements for Stalls and Urinals observed.

Yes	Sanitization protocols in place that address daily cleaning and disinfection with particular attention to frequently touched surfaces including both building, playground and buses.	Sanitization logs are available in all classrooms and offices, staff has received direction and training in proper sanitation techniques. Transportation Department personnel will sanitize the buses each day.

Yes	School doors and windows are operable and other air filtration measures in place.	All doors operable but windows do not open at this location. Merve 13 filters have been installed in the HVAC systems and staff has been directed to keep the doors closed to allow the filters to properly filter.

Yes	School ventilation systems are functional and meet standard.	Merve 13 filters were installed by the Deming Public Schools Maintenance crews and all systems are currently operating.

Yes	Evacuation plan in place that maintains 6 feet social distancing. Dismissal process in place that maintains social distancing.	Evacuation plans are in place and Social Distancing requirements have been discussed and will be practiced once students return to insure they are properly implemented.

Yes	Isolation rooms for symptomatic individuals in place and protocols for students exhibiting symptoms on buses in place.	An Isolation Room has been established in the Instruction Work Room, staff has been advised to keep doors shut to allow HVAC system to filter. The DPS Transportation Department has established protocols for students presenting with symptoms.

Yes	Protocols and signage in place for entrance into the building including temperature other symptoms check.	Protocols and signage is present at the entrance and throughtout the facility, temperature checks will be conducted on Staff, Students and any visitors allowed into the building. Hand Sanitizer is available at the entrance.

Yes	Signage across the school site that includes expectations for prevention practices: frequently washing hands, avoiding touching eyes, nose, and mouth, wearing masks, staying 6 feet apart and direction of traffic.	Signage in multiple languages as appropriate? Signage is in place throughout the school site to address face mask use, hand washing and Social Distancing, it is available in English, Spanish, Arabic and Somali to meet the student populations needs.
