Charter Schools are expected to update to the Department of Health COVID portal every week. Reports should be made by 10:00AM Monday on:

- ✓ The number of students and staff who are on school grounds or remote,
- ✓ The number of staff participating in surveillance testing,
- ✓ The number of positive cases from the prior week testing, and
- ✓ PPE supply on campus.

Charter Schools Program (CSP) Subgrant Applications

Charter Schools Program (CSP) subgrant applications for new charter schools and eligible high quality charter schools that are expanding their enrollment are available on the [PED's RFP, RFA, and RFI web page](#). Applications will be reviewed on a rolling basis in order to allow schools ready to apply early to have budget authority sooner, as well as allowing schools to have more time to prepare their applications if needed. Applications may be submitted any time after the application is released, but all Phase I Applications (Notices of Intent) must be submitted by **June 30, 2021**. Phase II Applications (submit only if the program manager has confirmed eligibility after submission of Phase I) must be received by **July 30, 2021**. Information about eligibility and funding amounts, as well as a complete subgrant calendar, is available on the [NMCSF Subgrant Competition web page](#).

CSP Peer Reviewers Sought

The competition for FY22 [Charter Schools Program \(CSP\) subgrants](#) opens in April 2021. Applications for CSP Subgrants are evaluated using a rigorous peer review process by a team comprised of one licensed NM teacher, one licensed NM business official, one licensed NM administrator, and one former or current charter school authorizer or authorizing staff, or high level education policy expert. Individuals interested in apply to serve as peer reviewers must apply by April 9, 2021, at 5:00 PM. The application is available on the [PED's RFPs, FRIs, and RFAs web page](#). Applications will be reviewed on a rolling basis. Potential reviewers will be notified by April 13 and should be available for a one hour training on the review process to be scheduled between April 14 and 16, and be able to begin reviewing the first applications the week of April 19-23.
