 24 their program, because I know she does a lot of  
 25 online and distance learning, and I had never had a

10	<p>1 lot of confidence in that.</p> <p>2 But in seeing what they were doing in Taos</p> <p>3 Academy, she really did kind of open my mind to a</p> <p>4 lot of different ways it can be super effective.</p> <p>5 Their campus is amazing. Their staff -- I was just</p> <p>6 so impressed with that school. So it's no wonder</p> <p>7 that it gets the accolades that it does.</p> <p>8 And I'm just very grateful. And I just</p> <p>9 wanted -- you know, to me visiting the schools is</p> <p>10 the absolute best part of this work and being around</p> <p>11 kids and everything. So just want to do a shout-out</p> <p>12 to Ms. Filiss, completely support of course the</p> <p>13 expansion, and they've just done an amazing job up</p> <p>14 there.</p> <p>15 THE CHAIR: Yeah. It looks like -- sorry,</p> <p>16 I thought you were done. Sorry.</p> <p>17 COMMISSIONER CARRILLO: Yeah.</p> <p>18 THE CHAIR: It looks like an exciting</p> <p>19 expansion when we looked at the plans. We were</p> <p>20 fortunate to have them let us hold a meeting up</p> <p>21 there when we were doing community input hearings.</p> <p>22 So we got a tour of the campus and -- yeah, they are</p> <p>23 one of the best examples of how you can do it in a</p> <p>24 hybrid manner very successfully. So thanks for</p> <p>25 that.</p>	12	<p>1 THE CHAIR: Okay. Thank you. We are on</p> <p>2 to Item No. 5, Discussion and Possible Action on the</p> <p>3 Rio Grande Academy of Fine Arts Board of Finance</p> <p>4 Application.</p> <p>5 And as was actually spoken about</p> <p>6 yesterday, when we're looking at the charter school</p> <p>7 program's funding, the school needs to have a Board</p> <p>8 of Finance in order to be able to start accepting</p> <p>9 those funds and be able to hopefully successfully</p> <p>10 carry out their implementation year, or whatever we</p> <p>11 want to call it, going forward.</p> <p>12 So this is actually remarkably early for</p> <p>13 schools. I'm glad they were able to get this</p> <p>14 together so quickly. So it's nice to see that</p> <p>15 they're moving forward so quickly. So</p> <p>16 congratulations to them on that.</p> <p>17 So -- oh, Commissioner -- Director.</p> <p>18 DIRECTOR CORINA CHAVEZ: Chair Gipson,</p> <p>19 members of the Public Education Commission, good</p> <p>20 morning. And, yes, I agree, this was very quick on</p> <p>21 the part of the school.</p> <p>22 Just after your meeting to approve the</p> <p>23 school, we provided them with the application so</p> <p>24 they could get it in and start to receive the</p> <p>25 federal Charter Schools Program grant, and I was</p>

State charters are their own Board of</p> <p>5 Finance. And so you'll see all the paperwork that's</p> <p>6 associated with it. And any time there is a change</p> <p>7 in board membership, they have to submit some</p> <p>8 documents to -- to change the Board of Finance so</p> <p>9 that all the current members of their board are</p> <p>10 listed in the Board of Finance documentation.</p> <p>11 THE CHAIR: Thank you. It is a profound</p> <p>25 amount of work that has been done by the Charter</p>	<p style="text-align: right;">16</p> <p>1 all the participants. But I think Sue Fox and Meg</p> <p>2 Meister are both probably online and would need to</p> <p>3 be promoted. I think we're going to -- you were</p> <p>4 going to call on them.</p> <p>5 THE CHAIR: If they wish, yeah. Yeah.</p> <p>6 Sorry.</p> <p>7 MS. JULIA BARNES: No, that's okay. And</p> <p>8 then I wanted to remind Commissioners that, in your</p> <p>9 folder, there are sample motions on these variety of</p> <p>10 topics if you care to take a look at that, under</p> <p>11 the -- my folder to you.</p> <p>12 THE CHAIR: Okay. Hold on.</p> <p>13 Commissioner Robbins?</p> <p>14 You're muted.</p> <p>15 COMMISSIONER ROBBINS: Sorry. Quick</p> <p>16 question. Does The GREAT Academy receive any</p> <p>17 federal funds?</p> <p>18 THE CHAIR: Oh. In terms of --</p> <p>19 COMMISSIONER ROBBINS: In terms of their</p> <p>20 operation.</p> <p>21 THE CHAIR: Any federal monies?</p> <p>22 COMMISSIONER ROBBINS: Any federal monies.</p> <p>23 Are they receiving any federal monies, grants, or</p> <p>24 otherwise?</p> <p>25 THE CHAIR: I would assume so. But the</p>
<p style="text-align: right;">15</p> <p>1 School Division, Melissa Sanchez, in particular,</p> <p>2 certainly the oversight by the Director, Julia, and</p> <p>3 Nathan, with this.</p> <p>4 And there's been meetings by the Executive</p> <p>5 Committee in looking at this. We've had discussions</p> <p>6 at our meetings regarding this. And, you know,</p> <p>7 the -- the conclusion that most have come to is that</p> <p>8 the concerns are around the foundation of the</p> <p>9 school. And the Commission at this point in time</p> <p>10 has little to no authority over the foundation.</p> <p>11 So that looking at the -- the concerns --</p> <p>12 and they're profound -- the recommendation is that</p> <p>13 the -- these concerns be sent over to those agencies</p> <p>14 that do, in fact, have greater authority and ability</p> <p>15 to do investigations.</p> <p>16 We're not an investigative agency. But</p> <p>17 the Attorney General and the Auditor's Office are,</p> <p>18 so that that is the recommendations that are being</p> <p>19 put forward here, is that the Public Education</p> <p>20 Commission give the direction to me to forward the</p> <p>21 concerns to those appropriate agencies, the Attorney</p> <p>22 General's Office, the Auditor's Office, and also the</p> <p>23 Office of the General Counsel and Licensure.</p> <p>24 Julia?</p> <p>25 MS. JULIA BARNES: I think -- I can't see</p>	<p style="text-align: right;">17</p> <p>1 Director can certainly answer that. But I would</p> <p>2 assume so.</p> <p>3 DIRECTOR CORINA CHAVEZ: Commissioner</p> <p>4 Robbins?</p> <p>5 COMMISSIONER ROBBINS: Yes.</p> <p>6 DIRECTOR CORINA CHAVEZ: The school is</p> <p>7 eligible for federal funds. It does not receive</p> <p>8 Charter School Program grants for expansion or</p> <p>9 start-up. However, they may have received some</p> <p>10 distance learning funds. I would need to do the</p> <p>11 research to confirm that.</p> <p>12 COMMISSIONER ROBBINS: That should be in</p> <p>13 their financial audit, and a quick review of that</p> <p>14 would reveal that. If there are any federal funds</p> <p>15 received for any programs, I would add to that into</p> <p>16 your referral to respective agencies to include the</p> <p>17 FBI.</p> <p>18 DIRECTOR CORINA CHAVEZ: Commissioner</p> <p>19 Robbins, I just wanted to confirm I heard back from</p> <p>20 Melissa Sanchez that they are receiving special ed</p> <p>21 funds and CARES funds as well.</p> <p>22 THE CHAIR: So I would -- I would also --</p> <p>23 and I could be wrong on this. But when the referral</p> <p>24 goes out to the AG's Office, in particular, based on</p> <p>25 the information and the investigation they did, they</p>

<p style="text-align: right;">18</p> <p>1 would then refer it out to, potentially, the FBI.  2 Correct, Julia?  3 MS. JULIA BARNES: I haven't looked at  4 that. I would assume -- I was just looking, too,  5 that this is appropriate under the -- under the  6 agenda. I think it is, because it says to  7 appropriate enforcement agencies --  8 THE CHAIR: Okay.  9 MS. JULIA BARNES: -- including the  10 Attorney General and the State Auditor.  11 So I think the conversation, Commissioner  12 Robbins, is acceptable under the agenda.  13 I think we can find out what would be the  14 appropriate way to do that, either to put that in a  15 letter to -- in the letter to the Attorney General,  16 and we can get back to you on what is the  17 appropriate thing.  18 And then, Commissioner -- Chair, I was  19 just going to offer, if we wanted to kind of go over  20 all of where the issues are, kind of a global  21 overview, we can do that. But I saw Commissioner  22 Carrillo's hand was up, too.  23 THE CHAIR: Right. Commissioner Carrillo.  24 COMMISSIONER CARRILLO: Thank you. I  25 would concur with Commissioner Robbins. And even</p>	<p style="text-align: right;">20</p> <p>1 I did want to also add, Chair, that the  2 school and the foundation put in a tremendous amount  3 of time as well providing us all this information.  4 So while the CSD staff worked very hard, they also  5 worked in close communication and were provided a  6 great deal of information from -- from the school  7 and the foundation.  8 So just to give everybody an overview that  9 was in my memo, which also went out to counsel that  10 are on -- on the Zoom right now, as everybody knows,  11 there is a court case. You already acted as a  12 Commission to non-renew the charter. That went to  13 the cabinet secretary, who upheld your decision, and  14 it has been appealed to district court.  15 That is a path that every school has on  16 these high-stakes decisions, and they opted to take  17 that path to district court. Many of these issues,  18 not in as great detail as we have right now, but  19 have been outlined for the court. So that decision  20 is there and pending. It's been fully briefed and  21 argued, and the court has taken it under advisement,  22 and we don't know when it will come back. It's up  23 to the court.  24 We're hopeful that it will be sooner  25 rather than later, but I don't think that anyone has</p>
<p style="text-align: right;">19</p> <p>1 though the AG might very well be the agency that  2 refers it to the FBI, I would want somehow that  3 included in the letter, you know, the seriousness of  4 all of this. I'm not sure how the others feel, but  5 I would agree with Mr. Robbins, Commissioner  6 Robbins, on that.  7 When you started -- I know that we're  8 going to get to this in the next agenda item. You  9 had said that most of the troubles -- or the  10 challenges, we'll say -- with The GREAT Academy had  11 to do with the foundation. I, here, just want to  12 state for the record -- and this will come up later,  13 of course -- that there are a lot of challenges also  14 on the academic side.  15 THE CHAIR: But this agenda item,  16 particularly, is about --  17 COMMISSIONER CARRILLO: Just what you  18 said, that we're looking at the found- -- I just  19 wanted to make that clear for myself for the record.  20 Thank you.  21 THE CHAIR: Sure. Julia, do you want  22 to --  23 MS. JULIA BARNES: Yeah. So I just wanted to start  2 with you have already taken actions.  3 The -- there is a pending stay for this  4 year. And if the court rules in a timely fashion,  5 either the -- your ruling -- your decision will be  6 upheld, and that could be further appealed so they  7 could still move forward to exhaust that -- move  8 forward to close the school.  9 Or, I'm anticipating, because you extended  10 the existing contract for one year, that if the  11 school was allowed to reopen, or the renewal -- the  12 nonrenewal decision being overturned would be  13 requiring you to renew the school, you would do a  14 new contract.  15 So you are in a short window of time to --  16 where I don't see that there is much to do that you  17 can do more than you have done with the school right  18 now; although, we are moving forward with the  19 proposed academic CAP, and there is a proposal right  20 now that you're looking at to refer out some of the  21 financial concerns.  22 So there is a short-term financial CAP  23 that Attorney Fox often says is not exactly a  24 corrective action plan; it was more an investigative  25 document. We are recommending that you close that</p>

<p style="text-align: right;">22</p> <p>1 out if you refer out to other entities.  2 We've gotten a lot of the information.  3 They have an ability -- other entities have an  4 ability to get more information if they need it. So  5 to close it out, not to say that your concerns are  6 satisfied, but that the information has been  7 received.  8 That is the next agenda item, one of two  9 financial CAPs. There's one for academics, and  10 there's one to close out the short-term one.  11 We put on the agenda so you have all  12 options available to you to do another financial  13 CAP; although, if the Commission decides to do that  14 we will need to negotiate that. There is not one  15 presently pending, with the decision instead to go  16 to other entities that have more authority.  17 The actions -- there's two actions related  18 to the foundation. Both are referrals out. One is  19 to the Attorney General's Office. As Commissioner  20 Robbins has stated, he may as well also want to  21 include another enforcement agency in that, either  22 as an addition or through that agency. We can  23 certainly look at that.  24 The next one is the State Auditor, because  25 foundations are a component part of the school's</p>	<p style="text-align: right;">24</p> <p>1 to speak now.  2 MS. SUE FOX: Shall I go ahead?  3 THE CHAIR: Yes.  4 MS. SUE FOX: All right. Madam Chair and  5 members of the Commission, I'm going to read a  6 prepared statement on behalf of the school.  7 The GREAT Academy has been transparent  8 throughout the CAP process, has provided all the  9 information requested by it from the -- from it by  10 the PEC and the Charter Schools Division, and has  11 responded to numerous questions posed by the PEC,  12 the CSD, and their legal counsel.  13 We don't believe further discussion of the  14 information provided in the memo will resolve  15 anything, and our silence regarding that should not  16 be viewed as acquiescence in it. The school firmly  17 believes that it has operated and continues to  18 operate in accordance with all laws and ethical  19 requirements applicable to charter schools and  20 charter school employees, and it does not oppose  21 review of any concerns by appropriate review  22 authorities with appropriate due process.  23 We hope that such review will result in  24 increased trust, confidence, and mutual respect  25 between the parties to the charter contract and a</p>
<p style="text-align: right;">23</p> <p>1 audit. We would send that information to the  2 Auditor to see if they wanted to take action.  3 Finally, the two referrals out potentially  4 to the Ethics Commission and/or the Office of  5 General Counsel, which oversees the Licensure  6 Bureau, those are ethics referrals out. Those  7 are -- I think they both ultimately lead to the  8 Office of General Counsel Licensure Bureau.  9 So I -- I -- I'm thinking that that is a  10 more direct referral, and those are related to  11 school employees.  12 So there's a variety of things, referrals  13 out right now. Again, proposed memos are in --  14 there's a -- are in that -- in a document in my  15 folder for you. So there could be three or four,  16 AG, State Auditor, the Ethic -- the Office of  17 General Counsel at PED Licensure Bureau, and then if  18 Commissioner Robbins and others wanted to add to it.  19 So that's where I think we are on Item 6.  20 And, Chair, I know that -- I don't know if  21 you would like to hear now from Sue Fox or Meg  22 Meister at this point, or if they would like to  23 speak. MEG MEISTER: Thank you. Meg Meister  5 with Modrall Sperling. And I have just a brief  6 statement on behalf of the foundation.  7 On behalf of The GREAT Academy Foundation,  8 we appreciate the opportunity to address the  9 Commission with regard to the school's financial  10 Corrective Action Plan. The foundation -- as  11 Ms. Barnes noted, the foundation participated in the  12 CAP process and voluntarily provided a huge amount  13 of detailed information, because the foundation  14 takes transparency and its support of The GREAT  15 Academy very seriously.  16 And we certainly appreciate the  17 opportunity to have reviewed Ms. Barnes' memo to the  18 Commission. Again, as Ms. Fox said, we don't  19 believe it would be fruitful to provide a detailed  20 rebuttal here to the matters in that memo, that our  21 decision to do so should not be viewed as an  22 agreement with the statements set therein or the  23 conclusions set forth there.  24 We recognize the Attorney General's role  25 under the Charitable Solicitations Act. We</p>

26	<p>1 recognize the Auditor's role with regard to the 2 foundation being a component unit. 3 Should the Commission choose to 4 communicate with the Attorney General's Office or 5 the Auditor regarding GREAT Foundation, we would 6 expect that the items laid out in Ms. Barnes' memo 7 would be the foundation of what's referred. To 8 include matters not noticed to the foundation with 9 specificity or giving the foundation an opportunity 10 to respond to those would be a violation of the 11 foundation's fundamental right to due process by 12 this Commission. 13 Thank you for your time. 14 THE CHAIR: Thank you. So, Commissioners, 15 we have several items that are included in the 16 motion. So I guess the first order is if it -- if 17 the Commission wishes to also include in the motion 18 the Attorney General, the State Auditor, and the FBI 19 in that motion.  10 what they need to do. But I think we are completing  
 11 the existing financial Corrective Action Plan, which  
 12 asked for information. That's basically what it

 14 So that portion, in my view, is complete.  
 15 There's not more that staff is going to do. If you  
 16 felt more comfortable just leaving it there -- you  
 17 tend to close out Corrective Action Plans -- I mean,  
 18 this is a little bit different, because we probably  
 19 should have called and requested information or  
 20 something.  
 21 THE CHAIR: Yeah.  
 22 MS. JULIA BARNES: So by closing this out,  
 23 we're just telling the school and the foundation  
 24 that the PEC and CSD staff are not going to be  
 25 seeking more financial data from the school. But if

 2 We're not doing anything with it.  
 3 COMMISSIONER CARRILLO: Okay. I  
 4 understand your explanation. It does seem like this  
 5 should have been called more a request for  
 6 information than a Corrective Action Plan, which  
 7 then leads me to why don't we have a financial  
 8 Corrective Action Plan?  
 9 And I -- hold on. I understand the need  
 10 for the data. But I also think there's the need for  
 11 making sure that, in these coming weeks and months,  
 12 that whatever procedures, financial procedures  
 13 they're using, and whether -- and withdrawals and  
 14 compensa- -- all these different things that have to  
 15 do with finances, why is there no plan to go forward  
 16 with that, since that's one of our biggest concerns?  
 17 THE CHAIR: That's 7-C.  
 18 MS. JULIA BARNES: 7-C. You could propose  
 19 that we negotiate an additional -- in my mind, it  
 20 would be kind of a new financial Corrective Action  
 21 Plan. So we could do it there. And then we could  
 22 bring that back to you.  
 23 I'm -- you know, a Corrective Action Plan,  
 24 like the academic one, we're looking to correct  
 25 something. And I think there is a shorter list of

1 items from the review of the information on the  
 2 school side that the CSD is going to follow up with  
 3 the school on.  
 4 That -- we were -- the proposal right now  
 5 is to do that outside of a Corrective Action Plan.  
 6 It could -- they were just going to follow up and  
 7 say, "Please correct these things that we saw."  
 8 One, I know, for example, is that -- is  
 9 that a couple of years ago, maybe three years ago,  
 10 the school entered into both -- Jasper Matthews had  
 11 both a -- he was an employee of the school and he  
 12 also got a contract back in 2017.  
 13 Well, you shouldn't -- you know, the CSD  
 14 is saying that that -- they shouldn't have even done  
 15 it that way, so they're going to go back to the  
 16 school and just confirm that they don't do that.  
 17 So there is a small number of things on  
 18 the school side and how they're running it.  
 19 Your larger concerns, first, are being  
 20 referred out to others. And, second -- but that --  
 21 I think we tried to draft a draft motion so that we  
 22 don't stop you from taking further action. But  
 23 maybe it isn't needed right at this moment. There's  
 24 not more data I think we can get or that we want.  
 25 And it's not -- others are going to look at your

1 issue and concerns.  
 2 But you are not precluded, even today,  
 3 that's why we added it to the agenda item --  
 4 COMMISSIONER ROBBINS: I see, yeah.  
 5 MS. JULIA BARNES: -- to do it any way you  
 6 want. So we wanted to preserve all of your options.  
 7 And we certainly could negotiate an  
 8 additional financial Corrective Action Plan. My  
 9 personal opinion is we still are no longer seeking  
 10 additional information from the school. We've  
 11 gotten a lot. We've gotten, I think, what we're  
 12 going to get. There is some missing data that is  
 13 missing. There was a QuickBooks file that was  
 14 deleted, and that's not small; it's large.  
 15 But, you know, you know, at this point,  
 16 I'm not hearing CSD staff wanting to try to recreate  
 17 that general ledger or whatever. These are -- to  
 18 refer it out was appropriate.  
 19 So you're correct. We should really make  
 20 sure that we're leaving open what you want to leave  
 21 open or moving forward on what you want to move  
 22 forward, and you have those options in front of you.  
 23 This is just how it appears to us.  
 24 COMMISSIONER CARRILLO: I see. As Chair  
 25 Gipson said, we can address that in 7-C. I want to

1 be clear if we're dropping this at this point on  
 2 7-A. Okay. Thank you.  
 3 MS. JULIA BARNES: Or next month. Or the

11 Academy was supposed to bring to us, you know, a  
12 good deal of information upon which we could make --  
13 we could work on the Corrective Action Plan.

14 And, yeah, that was on the 27th.

15 And then they had asked at that time --  
16 they didn't bring anything. They asked at that  
17 time, because there was a lot of information, if we  
18 could give them more time and then have a  
19 subcommittee meeting and do the work.

20 We did that. You know, I'm not  
21 remembering the date of the subcommittee meeting.  
22 And, again, much to our dismay, they came with no  
23 information. And that just -- I think that  
24 really -- well, for me, anyway, and from what I  
25 observed from the other people on the -- in the

1 subcommittee, that was a source straightaway of a  
2 great deal of frustration.

3 And, actually, it really felt like the CSD  
4 and the PEC were being, I would say, horribly  
5 disrespected, that we had taken the time to put  
6 together this meeting, and, again, the school  
7 offered no information.

8 And so toward the end of the meeting -- I  
9 do need to say that I did have to leave at 5:30. It  
10 started at 3:00. I really thought that by -- I  
11 thought two and a half hours would be plenty of  
12 time. I had to leave at 5:30. So I apologize for  
13 that.

14 And so now that I look at what's before  
15 us, I'm looking right now in -- I believe it would  
16 be Column B -- I don't see the heading -- under DASH  
17 Plan, there's a lot of phrases like, "Increased  
18 student academic growth and proficiency."

19 I don't know if we could be more vague. I  
20 don't know if we could be less -- if that phrase  
21 could have less accountability in it.

22 And I know that a great deal of this  
23 frustration that we had was we were tied to the  
24 contract -- I believe it was from 2016. And it  
25 really -- that kind of muddied the waters on the

1 entire process.

2 And, you know, the school -- our meeting  
3 was to have the plan, not to have the school develop  
4 a plan and then give it to us as a later date, which  
5 it says here, October 12th. This plan was supposed  
6 to be on -- I think it was the 13th. That was when  
7 we were supposed to have had this. And we didn't.

8 And now it's Friday, you know -- what is  
9 today's date? -- the 24th. So I have a real -- I'm  
10 very challenged by that, the inability to actually  
11 get this done in a timely, efficient manner with all  
12 the information that we needed.

13 And then the other -- if you look down  
14 again, "Improvement needs," "Professional  
15 development," could we be more vague? And I know  
16 this was negotiated down to the point where we could  
17 just get something done, evidence needed of relevant  
18 and meaningful.

19 You know, I've got to tell you. It's,  
20 like -- we need specificity, okay? If there is  
21 actually areas especially relative to math  
22 proficiency or English proficiency, there are very  
23 specific professional development plans that we  
24 could have requested to make sure that the students  
25 were getting the instruction that they needed.

1 And -- and in going further down -- and  
2 the date of completion on those, you know, 40th day,  
3 10/13/21; 80th day to the check-in and make sure --  
4 you know, as far as I'm concerned -- this is one of  
5 my biggest challenges with TGA -- is every day we  
6 don't -- every day that this school doesn't have its  
7 academic act together is a day that the children are  
8 falling further and further behind. It's a day that  
9 we have -- that the taxpayer money is not being  
10 spent judiciously, because the kids aren't learning  
11 the way they need to learn. And one just has to  
12 look at the graduation rate and proficiency rates  
13 for the school to learn that.

14 If we look at governing board training --  
15 no, that wasn't the one that really got to me,  
16 because I -- there's specificity there.

17 On EL services, falls far below the  
18 improvement needed. Evidence of student support --  
19 we need to show improvement.

20 I'm very, very grateful for everyone that  
21 was able to stay to 7:45 to finish this. But, you  
22 know, for me, personally, there's absolutely no way  
23 I'm going to vote for this particular CAP, because  
24 it really is -- it's too milquetoast, doesn't work  
25 for me. This school needs to be held accountable, I

<p style="text-align: right;">46</p> <p>1 believe at this point, at a very severe level. And 2 so there you have it. There are my thoughts on this 3 performance plan. 4 THE CHAIR: Okay. Julia? 5 MS. JULIA BARNES: I want to just say a 6 couple of things. 7 One is the contract has performance 8 indicators in it. And those remain. So just -- I'm 9 actually not trying to do a counterpoint to you at 10 all, Commissioner Carrillo. I just want to have 11 kind of an overall understanding as I see it. 12 So those remain. There was lots of 13 conversation as to whether we would also add 14 something else in here on math and reading growth 15 and proficiency and decided to rest on the existing 16 performance framework. So this doesn't change the 17 contract. It doesn't change that requirement for 18 them to report on that. 19 There is another mission-specific goal in 20 the contract as well. So the goal as written 21 remains. I just want to make that clear. 22 And then I think Sue Fox and I had quite a 23 few conversations about how we communicate well. 24 And the school, before your meeting, had come to me 25 and said that they had some questions. They wanted</p>	<p style="text-align: right;">48</p> <p>1 But we're here because none of that's been 2 adhered to. And the school, on its performance 3 levels, is very, very poor. 4 And I'm looking here at the history in 5 improvement needed. There is a history of 6 non-compliance in so many different areas. There's 7 a point at which -- and I often -- you know, I go 8 back to the experience I had in the private sector. 9 And, specifically -- I won't name it -- but a resort 10 up in Santa Fe. 11 And there, when you -- you know, I had -- 12 they set goals -- we agreed on goals for me in my 13 position as a food and beverage manager. And then 14 if the goals weren't met, there needed to be a 15 darned good reason why they weren't met. 16 And then there was my plan for meeting 17 those goals. And if they still weren't met, I'd be 18 out of a job. 19 And that's the concern I have here. We 20 keep just kind of kicking the can down the road 21 without anything having been met over the course of, 22 you know, five years. 23 And I completely understand what you're 24 saying, Julia, that all these mechanisms are already 25 there, but they've not been adhered to in the past.</p>

I 8 think that the school and the PEC and me and Corina 9 are committed to try to have as clear communication 10 as we can. So I know there's a point-counterpoint 11 to a lot of this. 12 I did want to tell you that they did come 13 forward with that. And I think that's a little bit 14 more of a complete picture. It's that phrase; right? And 3 I'm good for now. And if something comes up as a 4 result of other comments, then I'll raise my hand. 5 Thank you. 6 THE CHAIR: Commissioner Burt? 7 COMMISSIONER BURT: Thank you. So in my 8 review of the -- of the documents, I actually was 9 alarmed by the lack of kind of S.M.A.R.T. goals, if 10 you will. I mean, because 6 I -- I am ashamed of New Mexico's graduation rate. 7 It's abysmal. It's really sad, as a state. And so 8 to see The GREAT Academy's graduation rate be so, so 9 much lower than what our State average is, I mean, 10 we have to take drastic measures in this year in 11 order to ensure that these students are receiving 12 the education they need to graduate and succeed. 13          So I would like to look at some of these 14 items that we can put actual goals on today. And 15 then I would like to see The GREAT Academy 16 incorporate those into their DASH Plan. 17          And so I would start with the Next Step 18 Plans. 19          THE CHAIR: Okay. Can I just say? 20          COMMISSIONER BURT: Uh-huh. 21          THE CHAIR: If we're putting this in now, 22 the school's not here to weigh in on this. I think 23 we would have to have the subcommittee negotiate, to 24 have the school there. The school's not here to do 25 this. So I have a little concern with that.</p>

1 But I want to make clear that there's  
 2 also -- they have academic goals in their  
 3 performance framework. And that's why the  
 4 additional wasn't put in, because we would then be  
 5 renegotiating the contract, which was what we were  
 6 not doing.  
 7 So those academic goals already exist for  
 8 the school, that they are accountable for.  
 9 So those -- that specific, we did not do  
 10 because we weren't renegotiating the contract. If  
 11 that's what we want, then we have to go to the

 21 once a year.  
 22 THE CHAIR: I got it. But if you're doing  
 23 that and requiring additional, you are renegotiating  
 24 that contract.  
 25 COMMISSIONER BURT: We can use the

 2 see measurements towards that throughout the year.  
 3 THE CHAIR: I fully understand. But we're  
 4 renegotiating that contract, then, because they  
 5 already have those goals. That's what we fleshed

 2 THE CHAIR: We were just trying to finish.  
 3 DIRECTOR CORINA CHAVEZ: I just wanted to

 7 provided before the end of the school year.

If I heard Ms. Barnes correctly, there's 8 some reporting that would happen in January, and in 9 terms of results of academic assessments. And to 10 which I immediately thought to myself, great, that's 11 five months. Because my understanding of this 6 meeting today is that we were going over the CAP 7 that the subcommittee did. We were going to tweak 8 it, fine-tune it, and then approve it. 9 And what I'm hearing now is that we can't 10 really do any tweaking, because the school is not 11 here. And the things that we want to tweak, I'm 12 hearing that we can't tweak from Ms. Fox, because, 13 you know, it violates the contract, to which I have 14 to wonder is why are we having a CAP to begin with? 15 Because by the time all is said and done, April and 16 May are going to roll around. 1 THE CHAIR: Well -- and I want to make it  
 2 clear. I didn't say we can't make any changes  
 3 unilaterally. I said I have a level of discomfort  
 4 because the school isn't here.  
 5 COMMISSIONER CARRILLO: Okay.  
 6 THE CHAIR: So I -- you know, that's all  
 7 I'm saying. I can't answer. But I can say that I  
 8 don't think the intention was that there was going  
 9 to be public negotiations of this. I'm not talking  
 10 about tweaking.  
 11 We have not accepted contract negotiations  
 12 and CAPs, initially, and gone back and reworked them  
 13 and come back with what the -- what a subcommittee

 7 right. We could spend the next three hours

 9 I would be in favor of tabling this at  
 10 this time, asking the Commission subgroup to go back  
 11 and renegotiate the CAP with specifics, S.M.A.R.T.  
 12 goals for each and every item with specific time  
 13 deadlines for reporting and review.  
 14 COMMISSIONER DAVIS: I am in agreement  
 15 with Commissioner Robbins.  
 16 COMMISSIONER VOIGT: Madam Chair?  
 17 THE CHAIR: Yes, Commissioner Voigt.  
 18 COMMISSIONER VOIGT: Thank you. I agree  
 19 also that this is not the time or place. But I  
 20 understand everyone's concerns. But I just have to  
 21 say that what I'm really uncomfortable with is  
 22 public shaming of a school, regardless of what their  
 23 actions were. Public shaming is not the way to  
 24 resolve anything.  
 25 THE CHAIR: Thanks. And can the record

1 please reflect that Commissioner Chavez has joined  
 2 us? Thanks.  
 3 THE REPORTER: (Indicates.)  
 4 THE CHAIR: So I think the -- correct me  
 5 if I'm wrong. But I think the way to move is we  
 6 either make the motion to accept the CAP and it  
 7 fails, and then someone makes a motion for the  
 8 subcommittee to go back, or someone makes the motion  
 9 for the subcommittee to go back and continue  
 10 negotiations with the school.  
 11 COMMISSIONER ROBBINS: Madam Chair, I'd be  
 12 willing to make a motion.  
 13 THE CHAIR: Sure.  
 14 COMMISSIONER ROBBINS: I move that Item --  
 15 my note here --  
 16 THE CHAIR: 7-B, I think it is.  
 17 COMMISSIONER ROBBINS: -- that 7-B be  
 18 tabled and that the Commission, a subgroup of the  
 19 Commission, renegotiate the CAP with specific goals  
 20 and timelines to bring back to the Commission at  
 21 their October meeting.  
 22 COMMISSIONER VOIGT: I'll second that.  
 23 THE CHAIR: There's a motion by  
 24 Commissioner Robbins, a second by Commissioner  
 25 Voigt.

1 Commissioner Burt?  
 2 COMMISSIONER BURT: Thanks. I think I'm a  
 3 little frustrated and disappointed that this school  
 4 will go a month without a CAP and some clear  
 5 direction within the next month. So I am -- I'm  
 6 frustrated to kick this down the road.  
 7 It didn't sound like we were far off  
 8 from -- I mean, I -- once again, I don't -- I think  
 9 the changes that I suggested are pretty minimal.  
 10 They make -- I think they make sense. I think it's  
 11 pretty minimal. I didn't hear any other  
 12 suggestions, concrete, by any other Commissioners.  
 13 I think if it's those two items, I think  
 14 it could be a really simple five-minute  
 15 conversation. If the -- if the Director -- if  
 16 the -- if Mr. Matthews joins and is, like, you know,  
 17 we're going to have to have a further conversation,  
 18 then I'd be open to it. But it seems like it would  
 19 be a really simple thing to be able to start moving  
 20 this process forward, getting support to the school  
 21 that needs it, starting them on a pathway, getting  
 22 the direction, going with CSD. And I'm a little  
 23 frustrated to kick the can down the road right now.  
 24 THE CHAIR: Commissioner Taylor?  
 25 COMMISSIONER TAYLOR: Yeah. Thank you.

1 Commissioner Burt, I agree with you in that regard,  
 2 because I think what it also does is it continues to  
 3 extend deadlines by which the school has obligations  
 4 to, you know, to really report. The DASH Plan is  
 5 something that, by October 12th -- well, first of  
 6 all, let me say that I feel like the onus of this --  
 7 the burden is on the school to have -- to establish  
 8 a plan that's acceptable to raise the academic  
 9 standard and to reach those performance goals. That  
 10 is -- that's -- the burden is on the school to do  
 11 that.  
 12 That DASH Plan is the -- is one of those  
 13 steps in making that happen. And that's an  
 14 October 12th deadline.  
 15 So if we do table this and push it down  
 16 the road some more, then we go to our October  
 17 meeting, again, which will have deadlines for them  
 18 to establish their plans and so forth, which, in my  
 19 mind, just, is -- in my mind, kicks it down the  
 20 road.  
 21 I think what we do is we allow them to  
 22 come to us on this October 12th deadline with their  
 23 best -- with their best, you know, effort to  
 24 establish a plan. Then, in our October meeting, if  
 25 we need to, we can look at that and say, "Yeah, this

1 is good," or, "No, this is not acceptable. We're  
 2 going to -- this is how -- this is how we need to  
 3 proceed."  
 4 So I agree. I liked your changes,  
 5 Commissioner Burt. I think they just held some --  
 6 you know, and I don't know that we need any approval  
 7 from the school itself to implement those. We just  
 8 say, "This is part of the Corrective Action Plan to  
 9 date."  
 10 We can review this down the road; is that  
 11 correct?  
 12 THE CHAIR: Yeah. And let me make it  
 13 clear. They're doing the DASH Plan. Our acceptance  
 14 of this, whether we accept it or not, does not --  
 15 the school has already indicated to us they have had  
 16 the meetings. They are in preparation of doing the  
 17 DASH Plan. So this is included in there, because  
 18 they're already in the process of doing it.  
 19 They did not have one before. But they  
 20 just -- as we met that week, they had their training  
 21 on creating the DASH Plan. So this will not  
 22 interfere or affect in any way -- what we do here  
 23 affect their fulfilling that DASH Plan. So I just  
 24 want people to know that.  
 25 I'm not weighing in one way or the other

1 on what we should do. But I want people to know  
 2 that, yes, they would report, and we would see the  
 3 plan. And we can certainly do that by that October  
 4 date, because it will be done. Right now, it's

 19 when they reach -- when they had certain growth

 21 So I guess I just need a little clarification.  
 22 COMMISSIONER CARRILLO: KC has had his  
 23 hand up.  
 24 THE CHAIR: Okay. I'm not finished. I  
 25 needed clarification from Corina on the DASH Plan.

1 Is this something that they can just, at  
 2 some point in time, say no to, "We're not going to  
 3 do it?" Or now that they've committed to it, they  
 4 have to complete it? Because I do not know. So I

 2 Commissioner Taylor and Commissioner Burt. I guess

"And we're going to match that general 6 ledger with income that we know you're receiving and 7 also with the foundation." 8 And that's a directive. It's not a 9 question. 10 And then other directives around, you 11 know, receipts, all these different things that, 12 really, just people do in the private sector when 13 they run a business. And -- but we want to see it. 14 And we actually, at this point in time -- 15 as Vice Chair Voigt was saying, we have a right to 16 see it. And I would remind -- because we are the 17 chartering authority, okay? And I don't like the 18 idea of schools thinking they can run all over us 19 and that we're somehow toothless. 20 So I'd like there to be a financial 21 directives program. Thank you. 22 THE CHAIR: Can I just ask if they're on 23 monthly reporting now, to Budget? 24 DIRECTOR CORINA CHAVEZ: Yes, Chair 25 Gipson. They are on monthly reporting to School</p>
<p style="text-align: right;">95</p> <p>1 well, in Las Cruces, you have high schools with, 2 like, 2,600 kids, and people aren't making -- people 3 don't get into education to -- 4 THE CHAIR: Make money. 5 COMMISSIONER CARRILLO: -- to get wealthy. 6 They get into education because they love kids and 7 public education. 8 So what I'd like to know, because my 9 understanding from past conversations is that the 10 compensation package for the two key administrators, 11 the total compensation package, is significantly 12 more. And this actually goes into what Vice Chair 13 Voigt was saying. Because, as I understand it -- 14 and this is where, if Ms. Chavez has this 15 information and can tell me where to get it for this 16 meeting -- I understand there's car allowance, phone 17 allowance. There's been a great deal of travel, all 18 things we really don't expect from a charter school 19 and the use of public money. 20 And so I would definitely want to have a 21 CAP. But my challenge with having a CAP is going 22 through what we went through on the academic CAP. I 23 don't want there to be, like, a CAP, per se, as the 24 Commission does. Commissioner 3 Robbins, and then Commissioner Voigt. 4 COMMISSIONER ROBBINS: Yes. When I was on 5 the APS Board, one of the problems we had with a 6 charter school was the business officer was the only 7 one who was getting bank account statements. And 8 they were getting it from the bank, and then they 9 were fraudulently preparing those to give to the 10 Board of Finance or the governance. 11 I would like to ensure -- and I think this 12 is within our purview -- to require independent 13 receipt and review of the bank statement and 14 comparing that. 15 Now, it doesn't have to be CSD. It could 16 be an outside individual, or to ensure that someone 17 on the board is actually getting -- board of 18 governance -- is getting a copy of that bank 19 statement. Because this is where a lot of possible 20 financial mistakes, or -- I have to be very careful 21 what I'm saying, because I don't want to imply 22 anything. 23 But this is where you can double-check. 24 They write a check, but in their ledger, they record 25 it in a different way. And so when you see the</p>

1 actual checks going through the bank account -- it's  
 2 not that they just get a copy. They get a copy  
 3 directly from the bank. Since everything is  
 4 electronic these days, banks can send multiple  
 5 copies of your bank statement to more than one  
 6 individual.  
 7 And this was what was happening at this  
 8 one charter that -- and I think it happened at some  
 9 public schools. Only one person was getting that  
 10 from the bank. They would actually alter it and  
 11 then give that back copy to the superintendent and  
 12 things like that.  
 13 So, again, I would -- in a CAP that's  
 14 being discussed, I think that's one thing that you  
 15 could put in there to ensure the proper spending.  
 16 Yeah, the Budget group, you know, can look at the  
 17 budget and make sure the dollars are being spent  
 18 from their general ledger. But the bank account is  
 19 what gives you the double-check on the general  
 20 ledger.  
 21 THE CHAIR: Commissioner Voigt.  
 22 COMMISSIONER VOIGT: Okay. Thanks. So  
 23 will we need another subcommittee for a financial  
 24 CAP, or can we work this into the other -- this CAP  
 25 in with the other CAP subcommittee meeting?

1 THE CHAIR: Well, you know, I think we  
 2 have to look at a couple of things. I think -- I  
 3 wholeheartedly agree with the concern over how much  
 4 money is being spent by salary. However, I -- I  
 5 have a concern over our capacity to have the ability  
 6 to place restrictions on that.  
 7 COMMISSIONER VOIGT: Right.  
 8 THE CHAIR: I don't think we have  
 9 authority to do that.  
 10 COMMISSIONER VOIGT: Right.  
 11 THE CHAIR: And I think Julia can weigh in

 22 But my other point is, too, that for these  
 23 CAPs, the academic one and this financial CAP,  
 24 moving forward, we really need to have, at the  
 25 table, the bureaus from PED that can speak to the

1 compliance. Without that fact-finding, we have no  
 2 teeth.  
 3 And I think that's -- I just want to  
 4 comment back on the reason why we postponed the last  
 5 CAP is because we really need those people at the  
 6 table to have, you know, some legitimacy and  
 7 fidelity behind our work.  
 8 THE CHAIR: Right. And I think -- I think  
 9 part of the concern, when we're looking at the total  
 10 salaries, is that total salaries? Is that the  
 11 monies that are also obtained through foundation  
 12 monies? Because if it is, then that piece goes into  
 13 the complaint, and we can't -- you know, we -- you  
 14 know.  
 15 So that's -- and I think it is -- I think  
 16 Julia indicated, it's like 20 percent has to -- no  
 17 more than 20 percent for administrative salaries.  
 18 Is that what the --  
 19 COMMISSIONER VOIGT: It was 20-something.  
 20 It's like -- I think it's between 25 and 30 percent,  
 21 something in there.  
 22 THE CHAIR: Yeah.  
 23 MS. JULIA BARNES: My understanding,  
 24 Chair, is that that is in a legislative -- it's a  
 25 performance measure from 2020 in HB 2.

1 THE CHAIR: Right. But I thought it was  
 2 also tied to certain funding monies, I thought. I  
 3 could be wrong on that. But I thought when that was  
 4 put in there, it was, "This money is going to the  
 5 schools, and no more than that bucket of money can  
 6 be spent toward the -- no more than 20 percent can  
 7 be spent." I --  
 8 COMMISSIONER VOIGT: It's under  
 9 operational, I believe.  
 10 MS. JULIA BARNES: Sorry. I'm just trying  
 11 to find it. I'm not finding it quickly. I thought  
 12 I had highlighted it.  
 13 THE CHAIR: But I wholeheartedly agree. I  
 14 think, unless we have the other bureaus, the  
 15 entities that can provide the best information to

We have no purview there  7 in terms of what they pay each other and everybody  8 else. We do -- the only thing we have is the  9 ability to be able to want to see it. For all we  10 know, you know, next month they could easily cut  11 some salaries or cut one of the key administrators  12 and then end up bringing them back as a contractor.  13 There's all sorts of ways to massage  14 things. So that's one concern.  19 We are on monthly reporting. So Melissa  20 can collaborate with School Budget to review the  21 monthly reports that are submitted to the school. I  22 think that the -- the indicator of 68 percent of  23 funds going towards the classroom, you know, the  24 question is, how is that calculated? And if it's  25 separated out from the regular school budget,</p>

<p style="text-align: right;">106</p> <p>1 because there's contracts that are coming from 2 another source, not just the school, you know, 3 there's -- there's ways that I think salaries have 4 been supplemented. 5 I think the school has already put into 6 place some provisions that correct some of the extra 7 payments that folks were getting. 8 But Melissa is here, and she could be a 9 lot more articulate about the details, if that's 10 what we're discussing right now. 11 THE CHAIR: Okay. Thanks. And before we 12 move forward any further, I want to remind 13 Commissioners that the only thing on the agenda is a 14 Corrective Action Plan. And in the school's 15 contract, the prescriptive measure for concerns is a 16 Corrective Action Plan. So that a directive is not 17 on the agenda; a directive is not considered a 18 prescriptive plan in what we contracted with the 19 school. 20 So I just wanted to let Commissioners -- 21 make the Commissioners aware of that. Or is it our preference 6 to just simply ask her questions? 7 DIRECTOR CORINA CHAVEZ: And may I ask you 8 to be clear about if we're talking about a CAP for 9 this school year, we're not necessarily talking 10 about the historical set of events? Or you want to 11 know what has happened in the past, because -- 12 THE CHAIR: We're looking for a CAP for 13 this school year. 14 DIRECTOR CORINA CHAVEZ: Right. So that's where we are -- that's where we 8 are. 9 You know, one of -- my greatest concern is 10 to a change in the lease that would require a higher 11 lease payment, because, as it is, there -- 12 Ms. Barnes was able to make sure that there were no 13 additional prepayments. When the 6 foundation ended last school year -- or as of 7 June 30th, 2021, they were at \$46,000. So there's 8 really no -- nowhere for there -- for them to go. 9 One of the statements that had been made 10 by the head administrator a few times in regards to 11 the credit card was that schools weren't allowed to 12 have them. At that point, we'll be reading them 14 carefully and determining what areas of inquiry we 15 have. 16       And, at the same time, we are also 17 connecting with PED colleagues to get any other 18 additional information and data that exists at the 19 PED. 20       For example, the 40th-day count has not 21 yet occurred for this school year. We had to create 22 the Part A prior to that. So we will have more 23 updated information when we go into the school and 24 as we spend October and the first part of November 25 writing the preliminary analyses.</p>	<p style="text-align: right;">173</p> <p>1       And, also, right now, thinking about this 2 in terms of equity, identity, and what it means to 3 be a student in New Mexico, where your unique 4 identity, your history, your language, is valued and 5 expected to be part of your experience in school 6 settings, I think it's an unprecedented time right 7 now, and I think that there's a lot of people that 8 are trying to figure it out. 9       And so my appreciations are for all of 10 that. Thank you. 11       THE CHAIR: Thank you. We are on to Item 12 No. 13, which is Discussion and Possible Action on 13 the Liaison Reports. 14       The LFC just met. Secretary Steinhaus 15 mentioned it. I was able to listen in to some of 16 it. There was a report to the LFC in regards to 17 PED. I would encourage Commissioners on the PED 18 website, there is a link to see how schools -- how 19 much of the ESSA monies that schools have spent. 20       So if you're interested in, you know, 21 whatever schools, charters, schools in your 22 district, there is -- if you go on the PED website, 23 there is a link for that. So it is important 24 information, and you can parse it down to the -- to 25 the district and, I believe, the school.</p>

<p style="text-align: right;">174</p> <p>1           So just for your information, because that 2 is something the LFC is focusing on is how those 3 monies are being spent, because we are in a somewhat 4 unprecedented time for right now, that there's going 5 to be a substantial amount of money, it looks like, 6 that's going to be available for education, and 7 making sure that it's spent wisely outside of the 8 ESSA monies that's also there.</p> <p>9           So you can see how much monies the schools 10 had and where they are in terms of the spending of 11 that money. So if you want to check that out.</p> <p>12           The LESC met in September in Socorro. 13 Unfortunately, I had several other meetings, and I 14 was not able to get up there. So that's a 5 2 percent increase. I did stress how I felt that 6 several years, when there were some budget issues 7 and things like that, that no increase was given 8 whatsoever, even though inflation is still there and 9 things are going on.</p> <p>10 You know, they -- they tend to point out, 11 "Well, this is an optional program." And so, as we 12 mentioned yesterday, one of our legislative things 13 should make this a regular permanent thing.</p> <p>14 Currently, it's about \$17 million in lease 15 assistance. You know, taking it up to \$900, which 16 would have been the inflation rate since 2007, would 17 have brought it up to about \$20 million.</p> <p>18 There's plenty of funds available. I 19 don't know that there would have -- should have been 20 a restriction on that.</p> <p>21 The other thing that I pointed out 22 yesterday is how your typical charter school really 23 doesn't get the full benefit of the square footage. 24 Right now, the average charter school is only 25 covered, on a square-footage basis, about 60 percent</p>	<p style="text-align: right;">180</p> <p>1 help them flesh that out a little bit more in terms 2 of the design.</p> <p>3 The education network obviously is very 4 important, obviously, for the charter schools in 5 their far-flung areas, but for all of education. So 6 this would be something that would be eligible.</p> <p>7 It ties into the E-Rate that has been 8 available and will continue to be hopefully 9 available for several more years.</p> <p>10 Teacher housing is a big thing. And the 11 Legislature appropriated \$10 million for teacher 12 housing. You say, "Well, why does a teacher need 13 housing?"</p> <p>14 Well, some of the remote areas, they 15 cannot hire teachers because there's no affordable 16 housing, or even not affordable. There's just no 17 housing available in their areas. So in some of 18 these more remote areas or high-cost areas, the 19 schools actually build and operate housing for them.</p> <p>20 Sometimes they're single units. Other 21 times, they're like duplexes, things like that. But 22 there are many, many schools around the state where 23 some of these buildings are 30, 40, 50 years old. 24 They're not even of the quality of a mobile home 25 right now, and, you know. An old mobile home. New</p>
<p style="text-align: right;">179</p> <p>1 of their square footage is included. And that's 2 across all of the charter schools.</p> <p>3 The average charter school has about 4 80 square feet per student. The typical district 5 school has about 120 square feet for an elementary; 6 150, 160 for a middle school; and about 180 for a 7 high school. Albuquerque is even higher than that 8 at about 200 to 210 square feet per student in a 9 high school.</p> <p>10 So you can see that charters are -- not 11 only do they have a low lease rate, but they have a 12 very low square footage that they allow, even though 13 the square footage per student is very low.</p> <p>14 Some of the schools actually have square 15 footage of less than 40 square feet per student. 16 Again, they may be outdoors some and everything. 17 But there's times they have to be inside so, you 18 know, that's -- that's just not, in my mind, a very 19 reasonable measure. So I'll keep pushing on that.</p> <p>20 We talked also about IT infrastructure. 21 PSFA, Public School Facilities Authority, is working 22 on a state education network. They have a 23 blueprint. It's very -- it's conceptual at this 24 point. But they have authorization to spend up to 25 \$300,000 to get some professional consultants to</p>	<p style="text-align: right;">181</p> <p>1 mobile homes are probably nice. So they're putting 2 money into that.</p> <p>3 Demolition, the Legislature appropriated 4 funds, up to \$10 million a year, for demolition. 5 There are a lot of buildings on school property that 6 are not being used and should be demolished.</p> <p>7 One of the issues in demolishing some of 8 these buildings is you may have your basic 9 infrastructure tied to that building and the rest of 10 the building. Let's say the school is located where 11 all the infrastructure comes from, say, the main 12 street, through that now vacant building; and then 13 from there, it goes on to the other buildings 14 because it's just the location on the campus.</p> <p>15 Well, you can't just say, "We're going to 16 demolish this building, take out everything," 17 because your plumbing and electrical may run through 18 that building. So there's another issue.</p> <p>19 They have one school -- and I think it's 20 in Clovis; it may be up in Clayton. But there's one 21 school where they're not even using a big portion of 22 their campus. It's a multi-story building. They 23 cannot actually demolish that, because the boiler 24 for the entire school is in the basement of that 25 building, and it could cost millions of dollars to</p>

<p style="text-align: right;">182</p> <p>1 retrofit and move the heating/cooling system out of 2 that basement. So it's an interesting -- 3 interesting thing. 4 For this year, they will accept 5 applications on the systems-based awards for 6 demolition. 7 For the first year, they will only 8 consider stand-alone buildings. They're a little 9 bit simpler, so you don't have these problems where 10 they're connected, and you're, like, demolishing a 11 building and having to maybe fix your alarm systems 12 and electrical and things like that. 13 After that, stand-alone buildings will 14 still receive priority. 15 Jonathan Chamblin, at the end of this 16 month, will leave as executive director of PSFA. He 17 has taken a position with Sandia National Labs. As 18 you may know, they have a \$5 billion construction 19 program slated, and he will be an architect working 20 with them on that. So it's a good move for him and 21 his family, I think. 22 Unfortunately, we're going to lose out on 23 the four to five years of experience that he's 24 provided up till now. 25 Also Rachel Gudgel, LESC, resigned, and</p>	<p style="text-align: right;">184</p> <p>1 forward in a collaborative manner, as the Secretary 2 mentioned yesterday, and, as we move toward 3 legislative priorities, to be able to work together 4 on a number of issues that we certainly find in 5 common. 6 I want to also congratulate -- there were 7 91 National Merit semifinalists in New Mexico. And 8 six of them did come from charter schools. So I 9 want to congratulate all teachers that get their 10 kids to a place where they can take the SATs. 11 That's -- you know, that's a lot of work. 12 But the fact that there were 91 that are 13 from New Mexico and that I want to recognize that 14 Albuquerque Institute of Math and Science actually 15 had two, and that Explore Academy-Albuquerque, 16 Southwest Secondary, the ASK Academy, and Taos 17 Academy each had one. 18 So congratulations to all of those 19 schools, and, hopefully, those students will move 20 forward, because it means -- it means a lot -- it 21 means a chunk of money to help out toward college. 22 So that support is really important. 23 I want to thank -- I did send a message 24 but want to thank, once again, everyone who 25 participated in the CAP negotiations, although</p>

We had a heck of a time figuring out 5 how we were going to do this. And we're going to do 6 it in a hybrid way, where there are in-person, 7 regional events that will be held in Taos, Santa Fe, 8 Albuquerque, and Las Cruces. One will be a school 9 visit, and the other will be a reception. We may be 10 able to extend that out to Gallup as well. 11 But December 1st, the morning of December 12 1st, we'll start the conferences with a school 13 visit, and then that evening, we'll have a 14 reception. 15 During the day, there will be sessions 16 that will be held over Zoom. So we're going to find 17 safe ways to have smaller groups together throughout 18 the state. Each and every one of you will get the 23 formal invite and registration link. 24 And we're focused on equity, both equity 25 that -- the ways in which our charter schools are</p>	<p style="text-align: right;">189</p> <p>1 template that you can just put your school's name 2 in. 3 However, the hope is that the policy gets 4 you about 85 percent of the way there, something 5 that provides some good bones, but you'll need to 6 think about it, about that policy and how it 7 interacts with your campus. 8 We think that process is really important 9 for boards to go through. But we have just received 10 overwhelming feedback from charter schools that 11 putting together a new policy sometimes can be quite 12 arduous, especially with all the other things they 13 have going on. We're hopeful that this catalog of 14 policies that will start off with just a couple 15 steps, but will continue to expand as time moves on 16 here, can really save time. 17 And, of course, you know, as those 18 policies get implemented, and as we launch this, 19 we'd love to be sharing them with the CSD and PEC, 20 in case there are elements that they want to -- that 21 they have thoughts on. It's just 8 been hanging around for a long time. 9           And, of course, there was plenty of really 10 great testimony that gave great reasons why charter 11 schools are an added benefit, and, you know, a 12 partner of APS, which we feel, as charter schools, 13 just like we feel that the PEC is a partner of ours, 14 both entities have the right to hold us accountable. 15 It doesn't mean that that's not in play. 16           But I think partnership is important, and 17 I think we have it with APS. So thanks for 10 the action. 11           Of course, if there's, like, an issue, 12 we'll bring it up with you. We'll be running it both in the Senate and 9 the House. The Senate sponsors are Jerry 10 Ortiz y Pino, Siah Correa Hemphill, and Crystal 11 Diamond.
