



# What is the Summer Review Institute?

- ❖ Review of core instructional materials submitted by publishers.
- ❖ Reviewers are Level II and Level III educators from across New Mexico.
- ❖ Held each June for 2-3 weeks.
- ❖ Training provided prior to review institute.
- ❖ Purpose: to identify HQIM and provide a list of vetted materials for NM schools and districts to select from.
  - *High Quality Instructional Materials are content-rich, fully accessible, culturally and linguistically relevant, free from bias, research-based, and aligned to New Mexico state standards. They are written with clear purpose, effective lesson structure, and pacing to provide flexibility for teachers to best support learning for all students, encouraging inquiry and curiosity. HQIM provide a variety of relevant assessments to support and guide teachers with professional tools to evaluate student comprehension of the content and provide deeper understanding of the standards. HQIM also provide support to identify the linguistic and cultural lenses that students use to make meaning in the content area.*

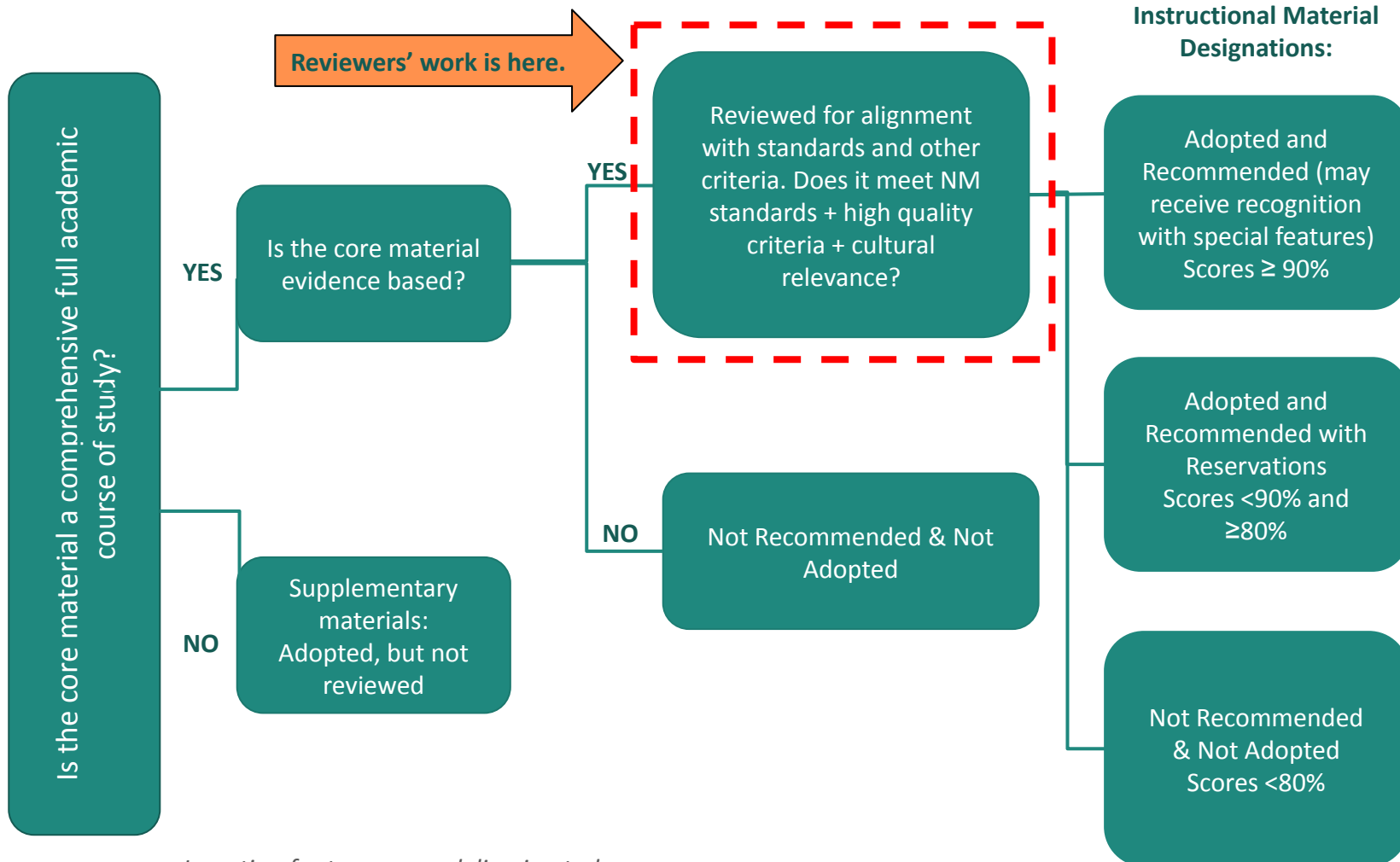

# NM Review and Adoption Process



# Reviewer Work



- ❖ Work in teams of 3.
- ❖ Review assigned titles during review institute.
- ❖ Use scoring rubric developed for content area by NM experts in the subject.
- ❖ Write appraisal of title with evidence and information about the instructional materials for districts and schools across the state.

**Individually review materials against standards and criteria within the scoring rubric.**

**Work with teammates to calibrate evidence and scores for the standards and criteria.**

**Collaboratively write an appraisal of each reviewed title as a team.**

# Training

## Purpose of Training:

- ❖ Preparation for review institute work
- ❖ Preparation and practice with institute documents
- ❖ Team-building and collaboration prior to institute
- ❖ Understanding and identifying CLR in instructional materials
- ❖ Understanding the importance of HQIM in the classroom and across the school and district

## Types of Training:

- ❖ Two day full-day training
- ❖ Live webinars after school hours
- ❖ Asynchronous training recordings
  - Training provided by the IMB in collaboration with NM content area experts and national experts in instructional material reviews.



# Commitments

## Time Commitment:

- ❖ Approximately 28 hours of training prior to review institute, including two day training
- ❖ In-person institute kickoff, 2-3 days, in Albuquerque
- ❖ Virtual review work, 8am-5pm weekdays, for the remainder of the institute

## Other Commitments:

- ❖ Work collaboratively with team members.
- ❖ Provide professional input on reviews of instructional materials.

- ❖ Review results posted on IMB’s website:
  - Adopted multiple list
  - Core titles ranked by score for each grade/subject
  - Review team appraisals of title posted for every title reviewed
- ❖ Review results posted to our [HQIM Reviews website](#):
  - Reviewed titles listed by grade/subject
  - Detailed information for each title, including review score and title designation; appraisal of title; video on structure of materials; special recognitions for the title; price; etc.

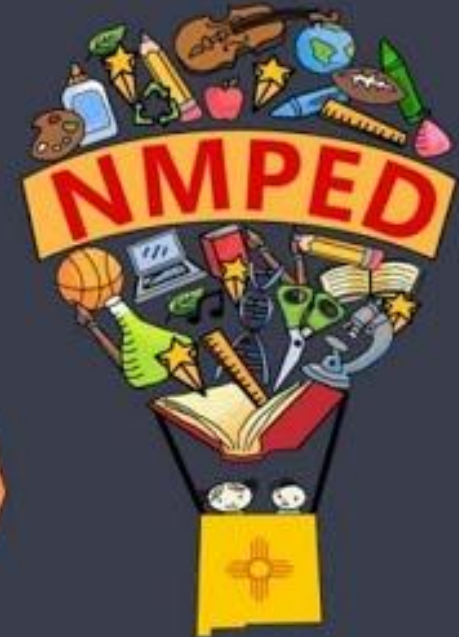
