










BIOGRAPHIES

Melissa Armijo-District 1

Melissa currently works as the Office Administrator at the National Hispanic Cultural Center Foundation where she helps raise money for the Center's many educational programs dedicated to the preservation and promotion of Hispanic culture, arts, and humanities. She previously served as the Special Assistant to the Dean of Students at the University of New Mexico and, while at UNM, served as the co-chair of the Staff Council Student Success Committee.

Melissa serves as the Board President of the Mark Armijo Academy Charter High School, an APS chartered charter school serving at risk youth, which was named after her late husband Mark who passed away in 2015. She is the co-founder and serves as the Vice President of the Armijo Family Scholarship Fund where she has helped raise and distribute more than \$100,000 in scholarships to New Mexico students who are majoring in the fields of education and STEM. She is also a current Board Member of Youth Development Incorporated. YDI helps families with childcare, early childhood development, as well as mentoring and job training services. In addition, she serves on the Technical Customer Advisory Committee of the Bernalillo County Albuquerque Water Utility Authority.

Melissa previously served as the Board President of the Gutierrez-Hubbell House Alliance, and on the Central New Mexico Community College governing board. Serving in various roles with Las Mujeres, Inc., she helped raise more than \$250,000 for scholarships for New Mexico women to attend New Mexico universities.

Melissa attended both New Mexico State University and the University of New Mexico. She is a 2018 graduate of Emerge New Mexico and has certifications in Women in Leadership and Non-Profit Management from UNM's Anderson School of Management.

Melissa is a lifelong resident of Albuquerque's South Valley who has spent her professional and volunteer career dedicated to providing educational opportunities to New Mexicans. Melissa and late husband Mark have two adult children, Aja and Christian, who are her most impressive accomplishments. David Robbins-District 2

David has over 14 years' experience in state government, and more than 30 years in the private sector. He holds a bachelor's degree in Economics and an MBA in Finance, both from UNM. His experience has included management, wholesale and retail sales, insurance, banking, utilities, education, consulting, public service, and construction.

David has been an adjunct professor of finance at the Anderson Schools of Management at the University of New Mexico. Glenna Voigt-District 3

Glenna Voigt was born in South Korea and raised in Albuquerque, NM. She obtained her B.S. in Education from the University of New Mexico and her M.A. in Educational Leadership from New Mexico Highlands University. Her Master's Thesis researched why traditional public-school teachers leave large schools to teach at charter schools. Prior to studying Education, Glenna served in the US Air National Guard as a Photographer, studied Mechanical Engineering at the University of New Mexico, and taught English in Tokyo, Japan.

With over 20 years in Education, Glenna was a Physical Education Teacher, Athletic Coach, and Principal with Albuquerque Public Schools and the Founding Principal of the first NM PEC authorized charter school, Media Arts Collaborative Charter School (MACCS). As a Teacher, Glenna also served as her APS middle school's Bilingual Coordinator, Literacy Coach, ESL

Glenna has a thorough understanding of the extensive and varied work involved in running a successful charter school.

Steven J. Carrillo-District 10

"As a parent, my hope for my son's future is rooted in the quality education he receives in our schools. The betterment of our children's education is my priority and it's why I've decided to run for school board."

My son is now 20, and a 2018 graduate of Santa Fe High School. That statement is as true today as it was when I was running for the school board in 2011. It is why I decided to continue my service to our kids and public education by serving on the Public Education Commission.

I was born and raised in Los Angeles to middle class parents; parents who were children of the Great Depression. It's from them that I learned the value of hard work, education, thrift, and service to others. Raised primarily by my mother it was instilled in me at an early age the importance of social responsibility and civic action. I graduated from Loyola High School in 1977 and in 1981, from Loyola Marymount University with a degree in film and television arts. But life had other plans for me.

In the early 80's I became very involved in efforts to end U.S. involvement in Central America. This led to work anti-nuclear work, walking across the United States in 1986, the Ukraine in 1988, and landing in Washington, D.C. I completed a program through the AFL-CIO Organizing Institute and spent the next year on the road in Mississippi, Illinois, Georgia, and Massachusetts organizing unions. This profound experience, organizing workers in lumber mills, hospitals, universities, and nursing homes, working in board rooms and on picket lines, shaped who I am today and cemented my commitment to social justice, equality, and equity. My work in organized labor led me West and on March 6, 1991, I ended up here in Santa Fe. In 1994 I declined to go on the road again. I found home.

The next fifteen-plus years I spent a working in the food & beverage industry and have extensive experience managing employees, budgets, and regulatory compliance. As a former business owner, I fully understand the importance of effective public schools in fostering economic development to the betterment of our state and our public charter schools

as an essential tool in preparing our kids for their future success.

When you work with unions, electoral campaigns, and employees, you learn how to collaborate; to listen to all sides and to reach the best possible solutions. By doing so we are all the real winners. Sometimes there is conflict and sometimes it's not pretty. And with regards to my nine years on the Santa Fe Public Schools Board of Education, my advocacy and passion for the success of our kids and our schools had never wavered, been compromised, or politicized. I bring this same commitment and advocacy for our state charter schools to my work as part of the PEC.

Aside from a longtime career in the food and beverage industry, managing and opening restaurants, my final professional career is in financial services. I'm thankful that this work essentially funds my education advocacy work and allows me to schedule my time to fully support our schools and our kids. I look forward to being an effective and relevant member of the Public Education Commission.
