Public Education Commission Educational Program Amendment

Purpose

The Educational Program Amendment Request is used to change the educational program as described in the charter contract. Note that any changes made need to support and align with the charter mission. The Amendment Request may not change the essence of the school's mission or program.

A change in the educational program is **not** effective until approved by the PEC.

Determining Eligibility

Not Applicable.

Submission Window

The *Educational Program Amendment Requests* may only be submitted for consideration **28 days prior** to any PEC meeting, and, if approved, will go into effect in the subsequent fiscal year. An *Educational Program Amendment Request Form* may be submitted by a charter school that meets the eligibility criteria. The amendment request will be placed on the agenda of the next regular PEC meeting if the complete request was received at least 28 days prior to the meeting, or at the subsequent meeting if the complete request was not received at least 28 days prior to the next regularly scheduled meeting.

If the fiscal year has started or will start prior to the request being considered by the PEC, an amendment request will be effective only in the subsequent fiscal year, if it is approved.

PEC Consideration

All performance data (academic, organizational, and financial) for the last three years including any outstanding compliance or investigations will be provided to the PEC for consideration of the amendment request.
