Public Education Commission Membership of Foundation or Component Unit Amendment

Purpose

The *Membership of Foundation or Component Unit Amendment* is used to notify the Public Education Commission of a change in the membership of an associated Foundation or Component Unit the primary purpose of which is to provide the school with financial support or that was specifically organized for providing the facility for the charter school, *which is identified in the charter contract*.

Changes to Membership or Officers of a Foundation or Component Unit do not require prior approval of the Public Education Commission; however, notice must be received within 30 calendar days of the change.

Submission Deadline

A Membership of Foundation or Component Unit Amendment must be submitted within 30 days of the change.

An administratively complete *Membership of Foundation or Component Unit Amendment* may be placed on the agenda of the next regular PEC meeting if the complete request was received at least 28 days prior to the meeting or at the subsequent meeting if the complete request was not received at least 28 days prior to the next regularly scheduled meeting.

A Membership of Foundation or Component Unit Amendment may be placed on the consent agenda of a regular PEC meeting for possible action by the Commission. Any amendment may be removed from the consent agenda during the scheduled PEC meeting for full discussion and possible action by the Commission.

PEC Consideration

All performance data (academic, organizational, and financial) for the last three years including any outstanding compliance or investigations will be provided to the PEC for consideration of the amendment request.
