RE: Letter Regarding TGA-NM Charter Impasse Appeal to PED Secretary

Dear Ms. Fox and Ms. Barnes,

This letter is pertaining to the Notice of Appeal submitted to my office by counsel on behalf of the GREAT Academy (TGA). The Notice of Appeal states that it has been submitted pursuant to NMSA 1978 § 22-8B-9(A), which provides that, upon receipt of an appeal by either party relating to a proposed amendment of a charter contract, I am to "finalize the terms of the contract."

Pursuant to NMSA 1978, § 9-24-8(B)(2) and NMSA 1978, § 22-8B-9(A), I am hereby delegating Vickie Bannerman, Deputy Secretary of Identity, Equity, and Transformation, the power to render a determination on this appeal in accordance with the Charter School's Act.

This agency is also in receipt of the brief in support of the appeal submitted by counsel for TGA, and the Response to Expedited Notice of Contract Impasse Appeal and Brief in Support submitted by counsel for the New Mexico Public Education Commission on June 8, 2022.

Either party shall have up to and including July 11, 2022, to submit additional briefing, in the event that either party chooses to do so, not to exceed ten pages. Further, either party has until

June 27, 2022, to submit any written objections to this process, or to submit requests for extensions for consideration.

Additionally, while a hearing may be requested and required by Deputy Secretary Bannerman during this administrative process to advise her of the premises, I have determined that the procedures outlined in Rule 6.80.4.14 NMAC do not apply to the Notice of Appeal, and no hearing is required in order to provide each party with sufficient opportunity for their arguments to be considered and to provide sufficient information to finalize the terms of the contract, as required by statute. Therefore, a hearing is not being set at this time.
