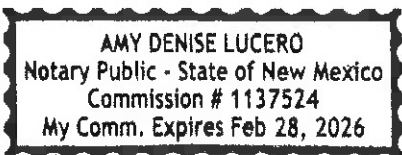


ASSURANCES
