In negotiating the last group of renewal contracts, the charter school attorneys requested that the 2018/2019 contract and processes be revised. There was an agreement to use temporary forms (an amendment to the existing contract or the 2018 contract as a placeholder) for the contracting and then work this fall to review and revise these documents. We are starting that process now. It will be a multi- meeting project, and we have invited all charter school attorneys to participate in a review of the documents. We are anticipating a vote on these new documents in **October 2022**. They will then be offered to the schools to be used immediately. This project will likely not line up with the timing of the Performance Framework project, but it is not necessary that it do so.

Overall the changes to the documents are as follows:

1) PEC Policy and Procedure Manual. I suggest that the PEC move towards creation of a virtual "PEC Policy and Procedure Manual" as done in Washington DC charter authorizing, which will contain all of the forms and policies that CSD has been creating and that you have been approving. This will create one combined virtual location for all documents and ensure that there is not similar information in various locations and possible conflicting information in various documents. It will shorten documents (like the Performance Framework that presently contains many pages of information not related to the Performance Framework).

Sections can include:

- a) New school application and timeline
- b) Planning year checklist
- c) Checklist for District Schools coming to PEC
- d) Contract
- e) Performance Framework
- f) Amendment forms
- g) Renewal Application and timeline
- h) Intervention Ladder and revocation process
- i) Closure

2) <u>Contract Form Changes</u>

- a) Clarify exhibits that are part of the contract and what are in an appendices. Add a table of contents for these and ensure that only needed documents are attached.
- b) Move all school specific terms to Section 3 (they were populated throughout the other contract)
- c) Simplify the organization:
 - i. Section 3 School related terms
 - ii. Section 4 Role and Responsibility of the Commission
 - iii. Section 5 Role and Responsibility of the Governing Board
 - iv. Section 6 Interaction between the parties
 - v. Section 7- Standard terms
- d) Took out terms in the contract not in the Charter School Act. Compliance with other laws is embedded in the Governing Board responsibilities.

3. Intervention Ladder

a) Added CSD technical assistance as a first step

- b) Put in a first initial meeting of the PEC in non-emergency situations, for the PEC to hear and discussion CSD/PED issues of concern and then give written notice of an intent to put the school on the Intervention Ladder. The decision to put a school on the intervention ladder would come at a second open PEC meeting. (This is the process you used for La Tierra these last two months.)
- c) Put in the protocols for revocation, including the hearing process, following the licensure rule.
