### **PEC Work Session Agenda**

#### 1. Call to Order and Roll Call

PEC Chair Rebekka Burt called the PEC Work Session to Order at 9:05 a.m. Technical difficulties with the sound delayed the beginning of the meeting. The meeting began at 9:20 a.m.

#### 2. Spotlight (9:00 - 10:00): Restorative Justice

Shawn Morris, Robert F. Kennedy Charter School and Tonya Covington, City of Albuquerque, discussed Restorative Justice with the PEC. Mr. Morris discussed the program at Robert F. Kennedy Charter School in Albuquerque. He began his discussion talking about Connection Circles and how they are used in the school with staff and students. Ms. Covington began her presentation asking the PEC to watch a video on Restorative Justice in Spokane Schools, because the technical issues prevented her showing the video. Her recommendation/suggestion in relation to Restorative Justice to the PEC were: Rethink having cops in schools; each school district should have one discipline plan, not each school having their own discipline plan; and to mandate Restorative Justice in all schools instead of thoughts and prayers following violence in schools. Commissioners actively discussed the issues. Ms. Covington mentioned that there are grants available to implement Restorative Justice in schools, but on one has applied for them.

#### 3. Update and input on Performance Framework

Commissioner Voigt gave an update on the Performance Framework. The group which meets on a weekly basis is looking more closely at the measures that the PEC uses to monitor charter school. Commissioners were asked to comment on the proposed edits and spent an extended time reviewing the document item by item.

#### 4. Introduction to Form Project Group 3: Contract and Intervention Ladder

PEC Attorney Julia Barnes began the discussion regarding the Contract and Intervention Ladder. Attorneys, Charter School Administrators, Matt Pahl, and school representatives were contacted to make comments on the draft document. Final draft will be brought back to the PEC for review and approval at a future meeting.

## 5. Continuing Review of Forms Project Groups 1 and 2: Implementation Year Checklist and Amendment forms

Deputy Director Brigette Russell discussed edits to the Implementation Year Checklist and Amendment forms.
