- F. Discussion & Action Items

A. GC Membership - Zachariah Ben and Mary Ben (Bidii Baby Foods, LLC). Kayla reached out for GC membership potentials.

- 1. Introductions from Zach B., GC members, and meeting attendees.
 - 2. Resumes for Zach B. and Mary B. as well as the letter of interest for Zach B. were shared via email with GC members.
 - Action made to vote in Zachariah Ben as a GC member. Motion made by Rebecca J., Second by Aaron B. Vote: 3-0-0. There is potential for MB to serve as an advisory consultant of grant writing for DEAP.
 - As a part of adding in new GC members the affidavit will need to be submitted to the PEC and Kayla will prepare and send via HelloSign, the document should be ready by Tuesday next week.
 - B. Student Cap presented by Kayla B.
- 1. First week of school.
- 2. 45 fully enrolled students, budget for 48.5 students
 - a. Building space has become a concern.

- i. 10th, 11th, and 12th grade is the majority of enrollment count. The school is out of computers and chairs. Take into consideration building space, funding, and resources.
- ii. Kayla B. inquired about putting a cap at 40? There would be a trade off in terms of funding. There are 6 lottery applications pending, which would mean adding six more students.
 - Charlotte A. informed that with the reduction of the enrollment count we'd lose \$36,000 and this could be more or could be less. This would depend on the sped count. Charlotte A. reassured that it could be afforded to do that this year.
- iii. Amberia T. brought up the concern of possible safety concerns when considering the cap as well and the potential of enrolling more students.
- iv. Aaron B. asked if there is a timeline or idea of when space can be expanded? There is no clear timeline, but a big focus area going forward. No pressure for a building by December, but the plans to have a building by June of next year. The timeline to work out and work with.
- v. DEAP needs a kitchen and classroom. These are the two highest needs.
 - I. If classroom space were to be extended then this can assist with raising the cap on enrollment; some numbers to consider would be 60, 65, or 80 even.
- b. Food program GC help and email was sent by Kayla B.
 - i. Not a part of the USDA national school lunch food program; there are challenges with compliances with the program, food preparing and storage, and complying and handling the compliance and requirements needed.
 - ii. Step back from the USDA food program.
 - In stepping away from the program the hope is to explore the possibilities.
 There are limitations with USDA. Reimbursement consideration within the program for items like mutton stew through the program, but it wasn't an approved food. It may have changed and the question is can exploration happen with adding traditional foods to the program database to allow reimbursement. If this can happen then maybe the program will be doable. It would need to be built to meet the needs for DEAP.
 - iii. Explore food opportunities that are more aligned with DEAP values.
 - 1. Family involvement
 - 2. Self sufficiency through student involvement, teaching skills, preparations, etc.
 - Learning from this there is potential plans for building up some school days
 out of the week and embedding a culinary class from it. This can be potentially
 funded from an NISEN, college and career, or CTE grant. As well as learning
 how to connect to a learning kitchen.
 - 4. Food dehydration suggestion by Zach B. as well as grants for procuring storage and resources for food services.
 - 5. Funding for a green house has been established for this year. Growing foods would they get certified.
 - a. Bidii can assist in the certification process and invest in local producers; Bidii is registered in a local cooperative and this can help get producers involved and become certified.
 - 6. Amberia T. is willing to help and volunteer if need be. Rebecca J. is also willing to help out as well. Biddi is happy to contribute produce.
 - a. A food handlers permit is required to prepare the foods and the training for it can be accessible online.
