That leaves us --8 9 for now, the only other item on the agenda is 10 Discussion and Possible Action on Contract and 11 Performance Framework for Explore 12 Academy-Rio Rancho. I don't know if it's Director Chavez first 13 14 or Ms. Barnes first. 15 Ms. Barnes. 16 MS. JULIA BARNES: Thank you. There was a 17 subcommittee that met and negotiated a contract with 18 Explore Academy-Rio Rancho. The two documents are 19 in the drive. If you look in the drive, there is a 20 PEC Meeting folder to the left. That's where the 21 documents are. 22 There is the Explore Academy-Rio Rancho 23 contract that has already been approved by their board, and the Performance Frameworks right after 24 25 that. The final two documents are the certification

from Explore that their board has done that.

I had e-mailed the subcommittee, and I just want to highlight that, that Explore Academy made two changes to the contract that I think are clarifications, but they are different from the document that came out from there.

The first one is on Page 7. The contract language itself says that the educational program has to indicate if students of various ages and proficiencies can be mixed in a classroom.

And that has always been in the Explore Academy documentation, so they just added that in there, and they fixed a typo. I e-mailed those to subcommittee Commissioners this morning.

Again, I don't see that as anything but a good clarification.

And I'm happy to answer any other contracts (verbatim), but I think it's more appropriate for the Commissioners and Director Chavez to talk about that. But I am happy to go over anything in the contract and how the language ended up.

THE CHAIR: Yeah. So we followed a process very similar to the spring when we were negotiating with the renewal schools in the spring.





And one of the -- one of the changes we did make 1 2 this time is, while we provided the option for 3 schools to move to a new Performance Framework 4 should one be approved and adopted, we have switched 5 it to that this school is required to move to the new contract and Performance Framework, should it be 6 7 ready and approved by, I think, early spring next 8 year. 9

So -- and they agreed to that, that that would be something they're willing to do. So that's one of the only differences that we did with this one versus the ones in the spring.

But there are the, you know, two
Mission-Specific Goals. And the educational program
was negotiated. So I think if any Commissioners
have any questions about this, I'm happy to call on
you for questions.

We do have -- there's also -- I saw in the Attendees, it looks like there may be a representative from Explore Academy. So if there's any questions for the school itself, I think we can bring them on as well if we need to.
