Foundation (Component Unit) Membership Notification Instructions

Purpose:

To notify the Public Education Commission (PEC) of a change in the membership of an associated Foundation (Component Unit).

Submission Deadline:

Changes to the Foundation board membership do not require prior approval of the PEC; however, notice must be received within 30 calendar days of the change.

Notifications completed 14 days prior to the next PEC meeting will be placed on the next agenda. Notifications of this type are typically placed on the consent agenda; however, any notification may be removed from the consent agenda and moved to the regular agenda for full discussion and possible action by the PEC.

Meeting minutes of the governing board of the school and the PEC (showing the respective boards were informed of this change) will serve as an amendment to, or compliance with, the charter contract regarding this personnel change.

Information provided by the School:

□ Fully completed form
☐ Foundation membership. The documentation must include a current membership list that contains printed names, email addresses and phone numbers of all members or officers of the foundation.
□ Conflict of Interest Statement: Provide a signed statement from all membership and officers disclosing all conflicts of interest in the relationship between the school and the Foundation that are created by any of the members or officers.
☐ Identify school personnel who work for, or are on the board of, the Non-Profit Foundation.
☐ School governing board minutes showing notification of the foundation membership change.
