Charter Schools Division Final Renewal Recommendation for New Mexico Academy for the Media Arts December 1, 2022

The Charter Schools Division (CSD) of the New Mexico Public Education Department recommends to the Public Education Commission that New Mexico Academy for the Media Arts be **renewed for a term of five years with no conditions**.

The school has not violated any of the terms of New Mexico Statutes Annotated (NMSA) 1979, Section 22-8B-12 K., and as stated in the CSD's Preliminary Renewal Analysis, the school has observable evidence to verify the educational program as delineated in the contract is being implemented with fidelity. The school has shown an increase in graduation rates over its contract term, outperforms both state and district reading and science proficiency scores, and has met or exceeded its mission goal for all but one year of its contract term (see <u>Preliminary</u> <u>Renewal Analysis</u>).

In the preliminary analysis, CSD reported that the school had not yet submitted its CLR Readiness Assessment, which affected their rating for 2.d. Equity and Identity. The school submitted proof of submission, and as a result, their rating was changed from **Demonstrates Substantial Progress** to **Meets the Standards**.
