










## BIOGRAPHIES

### **Melissa Armijo-District 1**

Melissa currently works as the Office Administrator at the National Hispanic Cultural Center Foundation where she helps raise money for the Center's many educational programs dedicated to the preservation and promotion of Hispanic culture, arts, and humanities. She previously served as the Special Assistant to the Dean of Students at the University of New Mexico and, while at UNM, served as the co-chair of the Staff Council Student Success Committee.

Melissa serves as the Board President of the Mark Armijo Academy Charter High School, an APS chartered charter school serving at risk youth, which was named after her late husband Mark who passed away in 2015. She is the co-founder and serves as the Vice President of the Armijo Family Scholarship Fund where she has helped raise and distribute more than \$100,000 in scholarships to New Mexico students who are majoring in the fields of education and STEM. She is also a current Board Member of Youth Development Incorporated. YDI helps families with childcare, early childhood development, as well as mentoring and job training services. In addition, she serves on the Technical Customer Advisory Committee of the Bernalillo County Albuquerque Water Utility Authority.

Melissa previously served as the Board President of the Gutierrez-Hubbell House Alliance, and on the Central New Mexico Community College governing board. Serving in various roles with Las Mujeres, Inc., she helped raise more than \$250,000 for scholarships for New Mexico women to attend New Mexico universities.

He is a former member of the Dream Dine' Charter School Governing Council, is a member of the ACE Leadership Charter High School's Foundation board and is the Vice President of the Farm Service Agency's Urban County

Committee for Albuquerque. Alan holds a BA from Goucher College, a Master of Arts in Teaching from Western New Mexico University, and an MBA from the University of New Mexico.

#### **Rebekka Burt-District 4**

Bekka Burt was born and raised in New Mexico and has represented District 4 on the New Mexico Public Education Commission since January 2021. She has a bachelor's degree in Elementary Education and a Master of Business Administration, both from New Mexico Highlands University. She is the Director of Education & Business Outreach for a local NM, start-up tech company in Albuquerque. She has worked for nearly a decade in education and government, starting her career as a middle school Language Arts teacher in Rio Rancho Public Schools, the same district from which she graduated. #### **Sharon Clahchischilliage-District 5**

Sharon Clahchischilliage is a native of New Mexico and a member of the Navajo Nation. She is from Gadii'ahi, New Mexico and was raised in Shiprock, New Mexico. She is retired and volunteers in many community roles to initiate and strategize to create plans of improvement.

Sharon began her professional career in education as a Special Education teacher of behaviorally challenged students. The education concept was ingrained in her from an early age and was taught that it was essential in the development of individual growth. She pursued a degree in teaching, however, Special Education seemed more challenging and rewarding. From her teaching experiences, she believes the way children are trained and schooled is a crucial demonstration of the way they are perceived and treated in a given society. Further, she believes that economic and social conditions define and drive educational structures and precedents.

Sharon taught in the Bernalillo School District, Albuquerque Public Schools, Farmington School District, Dine College, and Southwestern Indian Polytechnic Institute. She received her BSE degree from Eastern New Mexico University, Portales, NM and her MSW degree from the University of Pennsylvania, Philadelphia, PA. Initially she went to U of Penn to attend law school. The law school recommended that she complete the MSW degree first before going to law school. After earning her MSW degree she joined the Commissioned Corp, United States Public Health Service as an officer. Her tours of duty included the Indian Health Hospitals in New Mexico, Texas, and various military bases. After the completion of her tour of duty Sharon left as a Lieutenant.

Sharon served as a three term State Representative in the NM House of Representatives from January 2013 to November 2018. Throughout her political career, she has worked with seven Navajo Nation Chairmen and one Navajo Nation Speaker. The Navajo Nation appointed her as the Director of the Navajo Nation Washington DC Office. She worked under the administration of Presidents George W. Bush, Bill Clinton and the first half of the Obama administration. She also directed the National Council of Urban Indian Health in Washington, DC.

Sharon lives in Farmington, NM with her husband, Harry McCabe. They have one daughter, three sons, four grandchildren and one great-grandchild.

#### **Stewart Ingham-District 6**

Stewart Ingham was born and raised in Albuquerque. His parents, Stewart and Betty Ingham moved here after his father landed a job with Sandia Labs as an Electrical Engineer and worked there until he retired in 1992. Stewart attended Bandelier, Wilson, and Highland High Schools and Graduated in 1975. He started his college career at NM Tech where attending until December of 1979 when he switched from Metallurgy to Physics. He realized he wasn't interested enough to continue pursuing a career in any of these fields.

After trying several different avenues, he found himself in a laborer position building pool enclosures. This was his start in what became his career in construction. He progressed from laborer to carpenter to assistant superintendent. He received his contractor's license in 1986 and shortly after started at UNM in the Construction Management program and graduated in 1992 with a Bachelor of Science degree. Professionally, KT is an entrepreneur, educator, and researcher. Specifically, KT has businesses in New Mexico and Texas and works for the Jerry S. Rawls College of Business Administration at Texas Tech University. He earned his first Ph.D. in Hospitality Administration from Texas Tech University in 2018. KT is completing a second Ph.D. in Business Administration (Marketing) at the Jerry S. Rawls College of Business Administration at Texas Tech University. KT's

research broadly focuses on technology-marketing interfaces: technology-strategy, technology-consumer, and technology-pedagogy.

KT has published in the Journal of Business Research (the #1 ranked marketing journal according to Google Scholar) where his conceptualization of virtual reality was used as an organizing framework for the introduction to the special issue. Recently, he has had co-authored publications accepted to Marketing Education Review (the #2 ranked marketing pedagogy journal), Harvard Business Review, and the Journal of Macromarketing. Additionally, KT was selected as a winner of the 2020 AMS Review/Sheth Foundation Doctoral Competition for Conceptual Articles.

KT has presented over 15 research papers at national/international marketing conferences including Winter American Marketing Association (AMA), Academy of Marketing Science (AMS) Annual, Summer AMA, Association for Consumer Research, Society of Marketing Advances, AMS World, and SERVSIQ. ### **Steven J. Carrillo-District 10**

“As a parent, my hope for my son's future is rooted in the quality education he receives in our schools. The betterment of our children's education is my priority and it's why I've decided to run for school board.”

My son is now 20, and a 2018 graduate of Santa Fe High School. That statement is as true today as it was when I was running for the school board in 2011. It is why I decided to continue my service to our kids and public education by serving on the Public Education Commission.

In the early 80's I became very involved in efforts to end U.S. involvement in Central America. This led to work anti-nuclear work, walking across the United States in 1986, the Ukraine in 1988, and landing in Washington, D.C. I completed a program through the AFL-CIO Organizing Institute and spent the next year on the road in Mississippi, Illinois, Georgia, and Massachusetts organizing unions. This profound experience, organizing workers in lumber mills, hospitals, universities, and nursing homes, working in board rooms and on picket lines, shaped who I am today and cemented my commitment to social justice, equality, and equity. My work in organized labor led me West and on March 6, 1991, I ended up here in Santa Fe. In 1994 I declined to go on the road again. I found home.

The next fifteen-plus years I spent a working in the food & beverage industry and have extensive experience managing employees, budgets, and regulatory compliance. As a former business owner, I fully understand the importance of effective public schools in fostering economic development to the betterment of our state and our public charter schools as an essential tool in preparing our kids for their future success.

When you work with unions, electoral campaigns, and employees, you learn how to collaborate; to listen to all sides and to reach the best possible solutions. By doing so we are all the real winners. Sometimes there is conflict and sometimes it's not pretty. And with regards to my nine years on the Santa Fe Public Schools Board of Education, my advocacy and passion for the success of our kids and our schools had never wavered, been compromised, or politicized. I bring this same commitment and advocacy for our state charter schools to my work as part of the PEC.

Aside from a longtime career in the food and beverage industry, managing and opening restaurants, my final professional career is in financial services. I'm thankful that this work essentially funds my education advocacy work and allows me to schedule my time to fully support our schools and our kids. I look forward to being an effective and relevant member of the Public Education Commission.
