We, the undersigned, make up the governing body of the Southwest Preparatory Learning Center, located in Albuquerque, New Mexico.




We make this statement as part of Southwest Preparatory Learning Center’s application to the Public Education Commission for status as a board of finance under 6.80.4.16 NMAC.


