
## What we want to know:

Parents of students with disabilities (with IEPs) during the current school year selected to participate. Those selected will be contacted by phone, email and possibly mail.





# How will I know if I am selected for the survey?

Selected parents will receive a text and email from our contractor - Data Driven Enterprises. A paper survey may follow if a response is not received via text or email.

# What will PED do with this information?

The PED is required to report the data to the Office of Special Education Programs (OSEP) annually. When reporting to OSEP, only total numbers are reported, no personal information is shared.






## Are survey responses confidential?


