Hello, all -

Happy Friday Eve! Our team submitted a Notice of Proposed Rulemaking, to be published May 16, for the following rules:

1. 6.2.9 NMAC, Public Education Commission State Charter School Procedures (New)
2. [6.2.8 NMAC, Operational Bylaws of the Professional Practices and Standards Council](#) (Repeal, Replace)
3. [6.63.8 NMAC, Licensure in Athletic Coaching, 7-12](#) (Repeal, Replace)
4. [6.29.5 NMAC, English Language Development Instruction Requirements](#) (Amendment)
5. [6.32.2 NMAC, Language Acquisition in the Home or Heritage Language](#) (Amendment)

As promised, here are next steps. As you can see on the attached Notice...

- The public comment period will begin May 16 and will end at 5pm on June 21. The Notice provides information on how to obtain copies of the rule and how to submit feedback. Note that all feedback received after the comment period will be considered late and will not be part of the rule record.
- The public hearing will be June 21, 1:30pm -2:30pm, in Mabry Hall. The public hearing will be for all five of the proposed rules. Those providing feedback at the hearing will have three minutes to speak.
- Policy staff will also hold, on a date before the public hearing, an informal presentation session about the proposed rulemaking for tribal directors and leaders. *We will reach out to program ASAP to determine a date and time. This will be held virtually.*
- The Policy team will compile all of the feedback that is submitted within the public comment period and post it on our [Proposed Rules](#) page.
- The Policy team will work with program to review and consider the feedback. The feedback will help inform if or how the proposed rule changes before it is adopted.
- Assuming the changes do not require significant time to review, the rules can be adopted as early as July 7, and may be effective as early as July 18 (unless program specifically asked that the effective date be at a later date).
