Charter Contract
Between the New Mexico Public Education Commission
And
[NAME OF CHARTER SCHOOL]

This Charter Contract is hereby entered into by and between the New Mexico Public Education Commission (“Commission”), and [NAME OF CHARTER SCHOOL] (“School”), a New Mexico charter school, by and through the School’s Governing Body, known as the [name of governing body] (“Governing Body”) effective this ___ day of _____ 20___. Hereafter, each party may be referred to as “Party” or both parties as “Parties.”

WHEREAS, the Commission is created pursuant to Article 12, Section 6 of the New Mexico Constitution, with such powers and duties as are provided by law; and,

WHEREAS, the Commission is authorized pursuant to the Charter Schools Act to approve new and renewing charter school applications and to negotiate in good faith and execute, charter contracts that meet the requirements of the Act with the governing body of an authorized state charter school;

WHEREAS, the Commission is further authorized pursuant to the Charter Schools Act, to monitor charter schools’ compliance with the requirements of the Act, applicable provisions of the New Mexico Administrative Code and the Charter Contract;

WHEREAS, the Commission is further authorized pursuant to the Charter Schools Act to determine whether to approve a new charter school application and whether an authorized State charter school merits revocation, nonrenewal, or renewal with conditions;

WHEREAS, the Commission approved the School’s [new charter application/charter renewal application CHECK ONE] on [DATE OF CHARTER APPLICATION APPROVAL], and now enters this Charter Contract with the School’s Governing Body; and,

WHEREAS, pursuant to the Charter Schools Act, the Commission and the Governing Body wish to enter into this Charter Contract, in order to define each Party’s responsibilities, and identify the financial, academic, and operational performance expectations that will guide the monitoring, oversight and evaluation of the School by the Commission and the Charter Schools Division of the New Mexico Public Education Department.

NOW, THEREFORE, in consideration of the representations and mutual promises herein contained, the Commission and the Governing Body agree as follows:

SECTION 1: DEFINITIONS

Terms shall have the meaning as specified in this section wherever used in this Charter Contract, including the foregoing recitals, unless the context clearly requires otherwise. Where applicable, terms defined in the Commission Rule shall use the definitions set forth there.

“Chair” means the chairperson of the Commission, as elected by the members of the Commission, pursuant to the Commission’s Rules of Procedure.

“Charter Representative(s)” means the chair, president or other member of the Governing Body authorized by the Governing Body to legally bind the School to the Charter Contract and any other the

1 designated school official who will provide information to the Commission or CSD on behalf of the
2 School as set forth in this Charter Contract or Commission Rule.

3 “Charter Schools Act” means §§ 22-8B-1, *et seq.* NMSA 1978 as may be amended.

4 “Commission” means the Public Education Commission.

5 “Commission Rule” means a regulation governing the Commission’s oversight responsibilities
6 issued pursuant to the State Rules Act (§§14-4-1 to 11 NMSA 1978,) and codified as 6.2.9.1, *et seq.*
7 NMAC as may be amended. If the Commission Rule as contemplated herein is not codified, the
8 proposed Commission Rule, Exhibit D, shall govern the relevant provisions of this Charter Contract until
9 such time as the Commission Rule is codified, and the Commission Rule shall then apply, and Exhibit D
10 shall have no further effect.

11 “Commission Website” means the web page maintained by the Department on behalf of the
12 Commission and the location where the Commission posts and maintains as current the PEC’s
13 Procedures and its directives, instructions, templates and forms, and timelines adopted by it pursuant
14 to Commission Rule (6.2.9.7 Y. NMAC).

15 “Corrective Action Plan” means a plan developed by the School and submitted to, and approved
16 by, the Commission to remedy operational or financial violations or problems or address academic
17 performance issues under the Intervention Ladder pursuant to the Charter Schools Act and Commission
18 Rule (6.2.9.13. NMAC).

19 “CSD” means the Charter School Division of the Department as established by the Charter
20 Schools Act, §22-8B-17 NMSA 1978, to
21 A. provide staff support to the commission;
22 B. provide technical support to all charter schools;
23 C. review and approve state-chartered charter school budget matters; and
24 D. make recommendations to the commission regarding the approval, denial, suspension or
25 revocation of the charter of a state-chartered charter school.

26 “Days” means unless otherwise specified in a provision in the Commission Rule or applicable
27 statute, business days when the period referenced is 10 days or less, and calendar days when the period
28 referenced is 11 days or more. In computing the number of days, exclude the day of the event that
29 triggers the period, and include the last day of the period. If the last day is a day when the Department
30 or Charter School is closed, the period continues to run until the end of the next business day that the
31 Department or Charter School is not closed. Whenever a person or entity is required to act within a
32 prescribed period as defined by the Charter Contract, and written notice is served by mail or courier
33 service, three calendar days after service shall be added to the prescribed period required to act.

34 “Department” means the Public Education Department of the State of New Mexico.

35 “Department Rule” means 6.80.4.1 *et seq.* NMAC as may be amended.

36 “Facility” or “Facilities” means the facilities, including without limitation, all buildings
37 classrooms, and other spaces owned or leased by the School, and used by the School, its staff, teachers,
38 and students, for educational and related purposes.

1 “Governing Body” means the governing body of the School that shall operate as set forth in the
2 Charter Contract, as required by law and consistent with its governing documents.

3 “Head Administrator” means the School’s administrator licensed by the Department and hired
4 by the Governing Body to manage the day-to-day operations of the School with duties similar to that of
5 a superintendent as set forth in §22-5-14 NMSA 1978.

6 “Instructional Hours” has the meaning as set forth in §22-2-8.1 NMSA 1978.

7 “Intervention Ladder” has the meaning as set forth in the Commission Rule (6.2.9.7.Q. NMAC)
8 and are procedures adopted by the commission to impose interventions intended to address the
9 School’s unsatisfactory performance or non-compliance with the contract.

10
11 “Mission” means the stated educational and pedagogical purpose of the School consistent with
12 §22-8B-3 NMSA 1978 of the Charter Schools Act.

13 “NMAC” means the New Mexico Administrative Code.

14 “NMSA” means the New Mexico Statutes Annotated.

15 “PEC Procedures” has the meaning as set forth in the Commission Rule (6.2.9.7.Q. NMAC) and
16 are the Commission’s adopted directives, instructions, templates and forms, and timelines in support of
17 its authorizing practices adopted pursuant to the Commission Rule.

18 “Performance Framework” is a material term of this Charter Contract set forth in Exhibit A,
19 negotiated pursuant to §22-8B-5.3(E) NMSA 1978 and which includes the requirements of §22-8B-9 and
20 22-8B-9.1 NMSA 1978.

21 “Procurement Code” means §§ 13-1-28 to 13-1-199 NMSA 1978.

22 “Public School Finance Act” means §§ 22-8-1 to 22-8-49 NMSA 1978.

23 “Secretary” means the cabinet secretary of the Department.

24 “State” means the State of New Mexico.

The Governing Body shall govern the School as required by this Charter Contract and in accordance with all laws, regulations and policies applicable to it.

3.1 Public School. The Governing Body shall ensure that:

A. the School is operated as a public school consistent with the terms of the Charter Contract including the Performance Framework³ and all applicable laws, provides an educational program consistent with the requirements and purposes of the Charter Schools Act, and is governed and managed in a financially prudent manner according to accounting and auditing standards applicable to public entities in the State;

- 1 B. it employs a licensed Head Administrator who shall be held accountable by the
 2 Governing Body for staffing the School with qualified personnel, and who shall oversee the operations of
 3 the School;
- 4 C. the School is operated as a nonsectarian, nonreligious and non-home-based
 5 public school;
- 6 D. the School offers and provides a free public education to all school-age persons
 7 who are accepted for enrollment, through a lottery if there are more students seeking to enroll than

23 criteria set forth in the Performance Framework. (§22-8B-12(E.) NMSA 1978, and 6.2.9.12 and 13
24 NMAC) and the provisions of this Charter Contract.

25 **4.1.1 Annual Site Visit.** The Commission will conduct an annual site visit required by
26 the Charter Schools Act (§22-8B-12(E), NMSA 1978) using a Commission-approved annual site visit
27 protocol that is adopted pursuant to PEC procedures and consistent with the Commission Rule.

28 A. If the School believes that the CSD has conducted an annual site visit in a
29 manner that is outside the scope of the Commission-approved annual site visit protocol or in a manner
30 inconsistent with the Commission Rule, the School may provide written notice of the site visit objection
31 to the CSD, with a copy of the notice to Chair, within sixty days after it first receives the Phase 1 annual
32 report, identify the impact of the site visit objection on the Phase 1 annual report and request the action
33 that the School is asking CSD to take to remedy the site visit objection. If the issue is not resolved
34 between the School and CSD within 15 days, the School may provide written notice to the Commission

1 of the site visit objection and ask that the Commission take such action to address the site visit objection
2 either at the next public meeting of the Commission if the School believes that the site visit objection
3 requires immediate action or when the Commission issues its next annual report notice pursuant to the
4 Commission Rule. If the Commission is provided with a notice of a site visit objection, the Commission
5 shall either ensure that the site visit objection is resolved to the satisfaction of the Commission and the
6 School or, if not, allow the School to document its concern in the record of performance.

7 B. In conducting the annual site visit and development of the phase 1 annual
8 report as defined in the Commission Rule, the CSD, as staff for the Commission, and the School will
9 provide the required documentation, and adhere to the procedures, timelines and notice requirements
10 set forth in the Commission Rule (6.2.9.7.(W.) and (Y.), 6.2.9.12.(A.), (B.) and (C.)(1) and (2) NMAC).

11 **4.1.2 Annual Assessment.** The annual assessment will be conducted pursuant to the
12 Commission Rule (6.2.9.12.(C.)(3), (4), (D.) and (E.) NMAC) through the following:

13 A. An assessment of educational programming of the School set forth in Section 3
14 above and the performance indicators and performance targets negotiated between the Parties and set
15 forth in the Performance Framework;

16 B. An evaluation conducted during the annual site visit, as evaluated through the
17 CSD's review and the School's response to any such review or annual site visit;

18 C. Through the final annual report provided to, and accepted by, the Commission,
19 including CSD's findings and recommendations related to an annual report notice and the School's
20 response related to the annual report and recommendations; and

21 D. Through annual report notices provided by the Commission.

22 **4.1.3 Correction of Unsatisfactory Performance.** The School will correct
23 unsatisfactory performance by taking such action as authorized by the Commission in the Commission
24 Rule (6.2.9.13 NMAC) or otherwise established by the Commission in specific direction to the School.

25 **4.2. Performance Framework.** The Commission shall assess the School's academic, operational
26 and financial performance based on performance indicators and performance targets set forth in the
27 Performance Framework. The Performance Framework includes indicators and targets as required by
28 law or as negotiated by the Parties. The evaluation of the School's performance based on the
29 Performance Framework shall be conducted using the criteria set forth in the Performance Framework,
30 which shall not be modified without an amendment to this Charter Contract.

31 **4.3 Evaluation of the Performance Framework and Conditions.** The School shall maintain
32 records that evidence compliance with its obligations under the Charter Contract, including the
33 Performance Framework and any conditions imposed. The data shall be reported on the monitoring
34 documents referenced in Sections 2.1 and 3.2 above.

35 **4.4 Notification of Unsatisfactory Performance and Intervention Ladder.** The Commission
36 shall address the School's unsatisfactory performance or other performance deficiencies meriting
37 corrective action, up to and including those serious enough to lead to non-renewal, renewal with
38 conditions, or revocation pursuant to the procedures, timelines and notice requirements set forth in the
39 Commission Rule (6.2.9.12, 6.2.8.13, 6.2.8.15, and 6.2.8.16 NMAC).

1 **4.5 Renewal.** Within the time period established by the Charter Schools Act and pursuant to
2 6.2.9.15 NMAC, the Governing Body may submit a renewal application to the Commission on forms
3 approved by the Commission. The application shall include all information required by law. Legal
4 grounds for nonrenewal are articulated in §22-8B-12(K) NMSA 1978 of the Charter Schools Act. The
5 Commission shall follow the procedures and requirements of the Commission Rule before voting to
6 deny renewal or before imposing conditions on renewal of a Charter Contract.

7 **.4.6 Revocation.** The Commission may take action to revoke the Charter Contract in
8 accordance with procedures, timelines and notice requirements provided in the Charter Schools Act, the
9 Commission Rule, and the Department Rule. The Commission must demonstrate that the School has
10 violated any one of the reasons set forth in §22-8B-12(K) NMSA 1978 of the Charter Schools Act.

11 **4.7 Written Decision.** If the Commission revokes, does not renew or renews with
12 conditions, it shall state in writing its reasons and legal grounds for its actions established at the hearing
13 on the matter and comply with any requirements set forth in the Commission Rule and Department
14 Rule.

15 **4.8 Appeal.** If the Commission suspends, revokes, does not renew or renews with
16 conditions, the School may appeal the decision to the Secretary pursuant to the Charter Schools Act and
17 the Department Rule (6.80.4.14 NMAC).

18 **SECTION 5: ROLE AND RESPONSIBILITIES OF THE COMMISSION**

19 The Commission, as the Chartering Authority, shall take the following action.

20 **5.1 Comply with Legal Obligations.** The Commission shall conduct its oversight and
21 monitoring of the School in accordance with all laws, regulations and policies applicable to it, including,
22 but not limited to the Charter Schools Act, the Commission Rule, the Department Rule, PEC Procedures,
23 the Open Meetings Act (§§10-15-1, *et seq.* NMSA 1978) and the Government Conduct Act (§§10-16-1, *et*
24 *seq.* NMSA 1978).

25 **5.2 Timely Respond to Submissions.** The Commission shall evaluate all submissions by the
26 Governing Body or School, including amendment requests, and act in accordance with this Charter
27 Contract, the Charter Schools Act, the Commission Rule, and the PEC Procedures on each submission or
28 request.

29 **5.3 Commission Use of Withheld Funds.** Pursuant to § 22-8B-9 (B)(8) NMSA 1978, the
30 Commission will use the withheld funds of the school-generated program cost and provide details of
31 how the funds are used as follows:

32 By June 30 for each year of the term of this Charter Contract, the Commission shall direct the
33 CSD to post to the Commission Website an oversight and expenditure budget estimate for the upcoming
34 year using the monies withheld from the budgets of the charter schools authorized by the Commission.

35 Pursuant to § 22-8B-13 NMSA 1978, CSD may withhold and use up to two percent of the school-
36 generated program cost for its administrative support of a charter school.

37 **SECTION 6: ROLE AND RESPONSIBILITIES OF THE GOVERNING BODY**

1 **6.1 Comply with Legal Obligations.** The Governing Body shall conduct its oversight of the
2 School in accordance with all laws, regulations and policies applicable to it, including, but not limited to
3 the Charter Schools Act, the Commission Rule, the Department Rule, PEC Procedures, the Open
4 Meetings Act (§§10-15-1, *et seq.* NMSA 1978) and the Government Conduct Act (§§10-16-1, *et seq.*
5 NMSA 1978).

6 **6.2. Governing Body Membership requirements.** The Governing Body shall consist of no fewer
7 than five members, and the Governing Body; will require each member to comply with training
8 requirements consistent with law.

9 **6.3 Board of Finance Designation.**

10 **6.3.1 Required Information.** The Governing Body shall, at all times, be qualified and
11 designated to act as a board of finance as contemplated by §22-8-38(B), NMSA 1978 and Department
12 Rule, 60.8.4.16 NMAC and shall complete and keep current documents as required by PEC Procedures.⁹

13 **6.3.2 BOARD of Finance Suspension.** If at any time, the Governing Body's qualification
14 as a Board of Finance is suspended by the Department pursuant to § 22-8-39 NMSA 1978 or otherwise,
15 the Commission shall consider whether to issue a notice of breach under the Intervention Ladder as
16 defined by the Commission Rule or commence proceedings to revoke or non-renew the charter for
17 failing to meet generally accepted standards of fiscal management as contemplated by §22-8B-12(K)(2)
18 NMSA 1978. If the Commission decides not to revoke or does not deny a School's renewal because of
19 the Department's suspension of the board of finance, the Governing Body shall be required to develop
20 and successfully implement a Commission-approved Corrective Action Plan in consultation with the
21 Department to address the reasons for the suspension of the board of finance designation to obtain this
22 designation again within a reasonable time.

23 **6.4 Insurance Required.** The School shall obtain insurance coverage through, and in types
24 and amounts required by, New Mexico Public School Insurance Authority unless an exception is
25 provided as authorized by law.

26

27 **SECTION 7: INTERACTIONS BETWEEN THE PARTIES.**

28 **7.1 Facility Access Required.** The School shall allow the Commission and the CSD to visit the
29 Facility with reasonable notice to conduct the oversight and monitoring responsibilities as contemplated
30 by and in the same manner as defined in §22-8B-12 NMSA 1978, Commission Rule and this Charter
31 Contract.

32 **7.2 Commission access to School records.** The School shall provide information as may be
33 reasonably requested by the Commission upon reasonable notice which shall be no sooner than 10 days
34 unless exigent circumstances exist. The Commission shall direct CSD to first attempt to obtain the
35 information sought from the Department if the Department maintains the data through reporting
36 platforms, including but not limited to, OMBS and STARS. The Commission will utilize classroom or
37 school-level data when possible, will be provided with redacted student-level information if student-

1 level data is reported and will only be provided with students' personally identifiable information
2 consistent with the requirements of the Family Education Rights and Privacy Act (20 U.S.C. §1232g; 34
3 CFR Part 99). The Commission and CSD shall meet all requirements of 34 CFR Part 99.31 before and
4 after accessing student personally identifiable information.

5 **7.3 Records.**

6 **7.3.1 Student Records.** The School shall maintain student records in accordance with all
7 federal and State laws, including those regarding privacy and State public records retention
8 requirements.

9 **7.3.2 Student Attendance and Instructional Hours.** The School shall maintain daily
10 attendance records and comply with the number of Instructional Hours required by State law, based on
11 the grade levels served, which may be verified by the School's calendar submitted to the Department
12 during budget development and through the Department's STARS platform.

13 **7.3.3 Notice of Violation of Law.** The School shall

14 A. provide a written copy to the Commission of a final determination from a state
15 or federal court or administrative agency with jurisdiction over the subject matter of a violation of law
16 by the School;

17 B. comply with §22-10A-5.1 NMSA 1978 regarding reporting of ethical misconduct
18 and ensure compliance of the School staff with 6.60.9 NMAC related to the code of conduct for school
19 employees;

20 C. notify the Commission within 15 days of being notified by a governmental entity
21 with jurisdiction of a charge or a conviction(s) for any crime related to the misappropriation or theft of
22 School funds or property by a member or School employee. All personal identifiers shall be redacted
23 and not disclosed publicly by the CSD or the Commission unless compelled to do so, and

24 D. notify the Commission within 15 days if the School reports an issue to a
25 governmental entity with jurisdiction to investigate any crime related to the misappropriation or theft of
26 School funds or property by a member or School employee, or if the School is made aware of that the
27 Department is taking action against the license of one of its employees for any reason, including failure
28 to comply with 6.60.9 NMAC. All personal identifiers shall be redacted and not disclosed publicly by the
29 CSD or the Commission unless compelled to do so.

30

31 **SECTION 8: STANDARD TERMS**

32 **8.1 Notice.** Any notice required, or permitted, under the Charter Contract shall be in
33 writing and shall be effective immediately upon personal delivery, upon receipt of electronic mail,
34 or 3 days after mailing to the following:

2 **8.2 Applicable Law.** This Charter Contract shall be governed and interpreted in accordance
3 with applicable New Mexico and federal laws.

4 **8.3 Amendments.**

5 **8.3.1** Either party may amend this contract, and such request shall be considered in
6 good faith by the other.

7 **8.3.2** In the event of a change in a statute passed by Congress or the New Mexico
8 Legislature or a state or federal constitutional change that affects the rights or obligations of the Parties
9 to this Charter Contract, this Charter Contract shall be deemed to be amended to conform to the new
10 law unless to do so would cause an unconstitutional impairment of contract.

11 **8.3.3** If the Commission amends or modifies the Commission Rule during the term of
12 this Charter Contract, and the School believes that the Commission Rule change impairs the School's
13 rights, obligations or performance of this Charter Contract, the School shall notify the Commission
14 within ninety days, and the parties shall negotiate an amendment to this Charter Contract in good faith,
15 unless said Commission Rule amendment or modification is required by a change in state or federal
16 law.

17 **8.3.4** In the event of a change in the law or the Commission Rule, either party may
18 request that the parties clarify this Charter Contract as it relates to the law change. If a Charter
19 Contract amendment proposed by either Party cannot be agreed upon, either Party may appeal the
20 impasse to the Secretary as provided in § 22-8B-9, NMSA 1978. The Charter Contract shall not be
21 otherwise altered, changed or amended except as approved in writing by the Parties.

22 **8.4 Waiver.** Either Party's failure to insist on strict performance of any term or condition of
23 the Charter Contract shall not constitute a waiver of that term or condition.

24 **8.5 Invalid Term or Condition is Severable.** The provisions of this Charter Contract are
25 severable. If any term or condition is held to be invalid or unenforceable by a court of competent
26 jurisdiction, the remainder of this Charter Contract shall not be affected, shall be valid and enforceable.

27 **8.6 Assignment.** Neither Party may assign its rights or interest in this Charter Contract
28 unless authorized by law and agreed to by both Parties. The School may apply to a new authorizer at
29 renewal of the charter contract.

1 **8.7 Dispute Resolution:** Disputes between the School and the Commission shall be subject
2 to the dispute resolution process set forth in this section.

3 **8.7.1 Scope.** Except as otherwise provided herein, if either Party has a dispute regarding
4 interpretation or implementation of a Charter Contract provision, that Party shall present the dispute to
5 the other Party in writing. The following shall not be subject to this dispute resolution provision:

6 A. interpretation of state or federal statute, regulation, or policies applicable to the
7 Charter Contract, the School or Commission,

8 B. a CSD recommendation(s). or

9 C. the Commission’s authorizing decision(s) under the Charter Schools Act.

10 **8.7.2 Notice of Dispute:** Notice must be provided in writing that a dispute exists within
11 30 days from the date the dispute arises (“Notice of Dispute”). The Notice of the Dispute must describe
12 the dispute and provide:

13 A. the Charter Contract provision at issue,

14 B. the specific reasons the Party contends the other Party’s implementation or
15 interpretation of the Charter Contract provision is in error,

16 C. a statement of the facts giving rise to the dispute,

17 D. documents supporting that Party’s position

18 E. a desired resolution including specific language to clarify the Charter Contract,
19 and

20 F. the names of proposed neutral mediators, along with a description of the
21 qualification of the mediator and each person’s availability within a 30-day time period to hear the
22 dispute. The mediator shall not be an employee of the Department.

23 **8.7.3 Continuation of Charter Contract Performance:** The Governing Body and the
24 Commission agree that the existence and details of a dispute under this Section 8.7 shall not excuse
25 performance by either Party during the pendency of the dispute, except for any performance that may
26 be directly affected by such dispute.

27 **8.7.4 Response to Notice/Informal Process:** Upon receipt of a Notice of Dispute, the
28 Commission or the Governing Body shall have 10 days to respond in writing. The written response may:

29 A. Accept the proposal or propose an alternative solution to cure the dispute,
30 including specific language to clarify the Charter Contract;

31 B. Propose informal discussions to resolve the matter; and/or

32 C. Accept or reject the proposed mediator. If the proposed mediator is not
33 acceptable, an alternative name of a mediator, along with a description of the qualification of the
34 mediator and that person’s availability within a 30-day time period to hear the dispute. The mediator
35 shall not be an employee of the Department.

1 **8.7.5 Appointment of a Mediator and Mediation.**
2 A. Within five days of the written response, the Parties shall select a mutually
3 acceptable mediator.
4 B. If no mutually acceptable mediator has been selected within five days, the
5 Parties will jointly request that, within 15 days of the Parties' request, the Secretary identify an
6 available, qualified and willing mediator. The mediator shall not be an employee of the Department.
7 C. The Parties shall jointly retain the mediator and agree on a mutually-agreed
8 upon date and time for the mediation. The mediation shall be no later than 30 days from the date that
9 the mediator is selected, unless extenuating circumstances exist. The Parties agree to mediate the
10 dispute in good faith.

11
12 **8.7.6 Resolution and payment.**
13 A. Any proposed agreement reached in mediation must be memorialized in writing
14 and presented to, and approved by, the Commission and the Governing Body during public meetings of
15 those bodies prior to it being considered a binding agreement between the Parties.
16 B. The written agreement shall constitute an amendment to the Charter Contract
17 and shall be added to the Charter Contract documentation.
18 C. Each Party shall pay one-half of the reasonable fees and expenses of the neutral
19 third party. All other fees and expenses of each Party, including without limitation, the fees and
20 expenses of its counsel, shall be paid by the Party incurring such costs.
