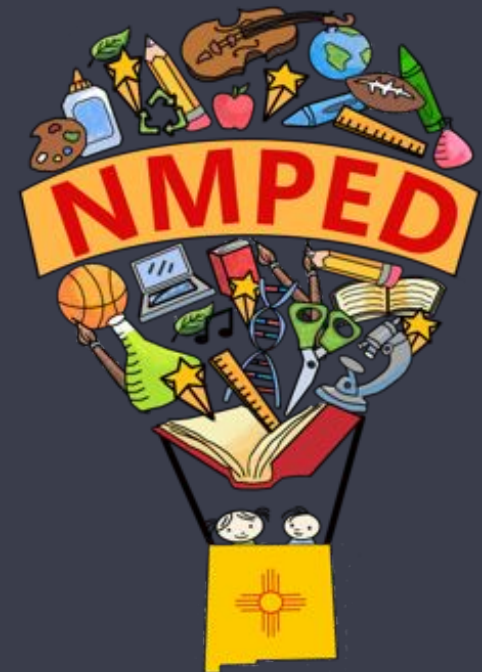

Recent OST Milestones

- More OST providers are planning to spend on programs to be reimbursed by ESSER this year.
 - Partnerships are solidifying to provide meals and other aspects of the programs.
 - Capacity is increasing. More children and youth are served because new staff has been hired.
 - The quality of programs is increasing as staff members engage in PD (professional development), and supplies and equipment are purchased.
 - Program directors are looking ahead to utilize new infrastructure.
 - Programs are expanding to new LEAs, new CBOs, and new student populations.

Nita M. Lowey 21st CCLC Program (21st CCLC)

What is the 21st CCLC? 21st Century Community Learning Centers, located in elementary or secondary schools or other similarly accessible facilities, provide high-quality services during Out-of-School Time (OST) hours (such as before and after school or summer break). Each eligible entity that receives an award from the state may use the funds to carry out many OST activities to advance student achievement.

Our focus is on OST programs built on student, family, and community voice as seed funding for a sustainable asset within Key Practice #3 of the Community School Strategy long term.

Span of the Current 21st CCLC Program: 2021-2026

Number of Sites Served: Over 120 Sites

Number of students served: Over 10,000 students served and climbing

ESSER III: Out-of-School Time

What is ESSER III? Federal dollars are provided by the Elementary and Secondary School Emergency Relief (ESSER) fund. ESSER III is the American Rescue Plan (ARP) which was passed on March 11, 2021.

- Date/Span of the ESSER III (ARP) Grant
 - *Round 1 spans August 5, 2021- June 30, 2024
 - *Round 2 spans Sept 9th of 2021- June 30, 2024
 - *Round 3 spans March 3rd of 2022- June 30, 2024
- Number of Sites Served
 - *Over 30 Sites
- Number of Students Served
 - *Over 400 Students Served by the 2nd Year (see 1st yr chart)

K-12+ and OST

The [K-12 Plus Program](#) is an optional program that seeks to increase the amount of time students are learning, especially for the purposes of improving academic achievement and test scores, or reducing learning loss, and achievement gaps.

OST can be counted as additional time toward K-12+ IF all conditions are met including:

- OST program is offered to ALL students for FREE
- transportation is provided by the school
- minimum of 2 continuous hours per OST activity
- healthy snacks provided
- OST program is not currently funded by other means - 21st CCLC, ESSER, HB2, etc.

HB2 OST Funding

- New state funding beginning in FY24 (July 2023)
- Budget line item for “out-of-school learning, summer enrichment, tutoring, and programs to address learning gaps.”
- Funding for OST programs:
 - RFA for LEAs - recently closed
 - RFP for CBOs - coming soon

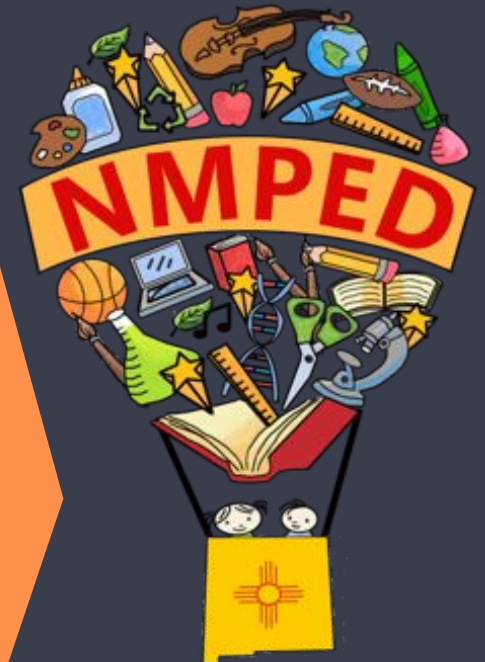
