# **ECECD Tribal Advisory Coalition**

- ECECD, in partnership with the **University of New Mexico** Family Development Program, established a Tribal Advisory Coalition in the Spring of 2022.
- As of April 2023, 18 members have been appointed or requested to join the coalition, still awaiting 7 representatives to be nominated by their Tribal leaders.
- The coalition will be formed of 30+ members, and we plan to have one representative and alternate from each of the 23 Tribes, Nations and Pueblos in New Mexico.
- Includes a representative from for the New Mexico School for the Blind and Visually Impaired and New Mexico school for the Deaf (they have nearly 10% population of Indigenous children/families)








# **Advisory Coalition Goals**

#### The coalition planning group developed five major goals:

- 1. Identify the strengths and gaps of early childhood education and care in each community;
- 2. Learn from each other across tribal communities to develop culturally relevant and appropriate assessments, evaluations and innovative family engagement models;
- 3. Develop best practices of collaboration in governance and financing structures;
- 4. Communicate regularly with ECECD and make broad recommendations about tribal early childhood education and care needs;
- 5. Strengthen ECECD's commitment to equity and quality early childhood education and care for all.
