Wow! I just perused the new AIMS website and it is bright and beautiful! Congratulations on transitioning it over.

I am noticing a few items that still need to be addressed, however, so I do not consider this issue resolved.

- There is no information on the Governing Board membership, the names of the GC members and contact information is no where on your website
- The "Documents" section has a link to "CG Agendas and Minutes" that is empty; I see no place where you have provided notification on GC meetings, the agenda, or minutes.
- In the "Academics" section there is a link to old (2018 report card) data, this should be updated to the recently released VISTAS data.

- The link to the <u>2023-24 application</u> perpetuates the concern we have raised at AIMS for the past two years: the lottery application is still confusing and is not separated from the registration form.

The letter from Martin Esquivel dated June 7<sup>th</sup>, in response to the May 1 letter I sent you (attached) assured us that the Lottery and Enrollment packet would be separated and GC info would be included. It is not.

On Friday, July 14, 2023, we are finalizing the July 21st PEC agenda. If the website is not corrected by then I will have no choice but to bring this item before the Public Education Commission. We have worked for months to provide you opportunity to resolve the concerns. They are not resolved.
