Charter Schools Division Analysis and Recommendation New School Application Virtual Preparatory Academy of New Mexico July 2023

Dr. Kayleigh Carabajal and Freda Daugherty have applied¹ to open a new charter school, Virtual Preparatory Academy of New Mexico, within the boundaries of Portales Municipal Schools to serve grades K-12.

Based on the analysis set forth below, which includes the peer review team's evaluation of the new charter application and capacity interview, as well as a brief summary of the community input hearing and written community input received, the Charter Schools Division (CSD) recommends that the application be:

□ **Approved** – The application is complete and adequate; and during their Capacity Interview, the applicant(s) demonstrated a clear capacity to implement the academic, organizational and financial management plans as described in the application. Nothing was identified that would indicate the applicant(s) do not have the experience, knowledge, and competence to successfully open and operate a charter school.

□ Approved with conditions – The application is complete and adequate; and during their Capacity Interview, the applicant(s) demonstrated a general capacity to implement the academic, organizational, and financial management plans as described in the application. However, the CSD has identified some specific concerns that would need to be addressed during the planning year. The CSD has listed the noted concerns and conditions to address the concerns below. If the PEC determines that there are any additional conditions that need to be

addressed, those should be noted during the public hearing and all approved conditions negotiated in the final contract.

Denied – The application is either incomplete or inadequate; or during their capacity interview, the applicant(s) did not sufficiently demonstrate the experience, knowledge, and competence to successfully open and operate a charter school in New Mexico.

The Charter Schools Act, in NMSA 22-8B-6 M states that a chartering authority may deny an application if:

- (1) the application is incomplete or inadequate;
- (2) the application does not propose to offer an educational program consistent with the requirements and purposes of the Charter Schools Act;
- (3) the proposed head administrator or other administrative or fiscal staff was involved with another charter school whose charter was denied or revoked for fiscal management or the proposed head administrator or other administrative or fiscal staff was discharged from a public school for fiscal mismanagement;
- (4) for a proposed state-chartered charter school, it does not request to have the governing body of the charter school designated as a board of finance or the governing body does not qualify as a board of finance; or
- (5) the application is otherwise contrary to the best interests of the charter school's projected students, the local community or the school district in whose geographic boundaries the charter school applies to operate.

CSD Analysis and Recommendation

The Charter Schools Division acknowledges that the Virtual Preparation Academy New Mexico application has many strengths, and the founders bring a wealth of experience. However, this application is inadequate. During both the application review process and the capacity interview, the application team failed to demonstrate the capacity to implement the academic, organizational and financial plans to make this a viable school. The team is not yet prepared to open a high-quality charter school.

The academic section peer ratings are split with nine (9) responses meeting criteria and nine (9) approaching. In the organizational section of the application, out of twenty-three (23) indicators, there were six (6) that scored as "does not meet criteria" and fourteen (14) indicators that were scored as "approaches criteria," leaving only three (3) indicators that met the criteria. In the financial section, out of eight (8) indicators, four (4) did not meet the criteria, three (3) approached, and only one (1) item met the criteria. While we are not looking for perfect scores in all sections, **most** of the indicators should **meet the criteria** in order to be considered a strong applicant for a new charter school.

Schools that have been approved in previous years had application reviews and capacity interviews where the vast majority of indicators met the criteria in all major categories, and had

very few, if any, "approaches" or "does not meet" criteria ratings. In fact, in the past five (5) years, we have not approved any schools with more than three (3) indicators in total that did not meet criteria (application and capacity interview combined). This does not mean that a school with 3 or fewer indicators that did not meet criteria would be approved, as some schools have been denied with as little as one (1) indicator that did not meet criteria but were denied because the indicators and other considerations carried more weight. Below are concerns noted by CSD.

<u>Virtual Education</u>: In addition to scoring indicators on the application and capacity interview, we have concerns about the model and how it will be implemented. In 2015, the Center for Research on Education Outcomes (CREDO) at Stanford conducted a nationwide study of virtual charter schools which demonstrated that virtual charter students performed far below their peers in math and reading. In their analysis, they estimated that virtual charter school students lost "72 days of learning in reading and 180 days of learning in math, based on a 180 day school year" (<u>CREDO 2015</u>). Further, New Mexico's Legislative Education Study Committee (LESC) report dated January 2021, cited a 2018 study of virtual charter schools in New Mexico that had similarly concerning results. LESC's report concluded that the virtual charter schools had much lower academic outcomes in math and reading than brick-and-mortar schools serving similar demographics (<u>LESC 2021</u>).

We are concerned about the potential for these issues at VPA. Unfortunately, the studies (CREDO and LESC) were accurately foreshadowing what might happen during covid. Online learning did not work for most students during covid. A staggering number of students fell way behind academically (Harvard Center for Education Policy Research, May 2022), and their social-emotional well being suffered greatly (Rutgers 2023). This continues to be an issue because they have still not recovered, and at-risk students (e.g.: economically disadvantaged, mental health issues, disabilities, ELs, etc.) were hit hardest (NWEA 2023). Therefore, we only see a very limited number of students who would be served best by a virtual model.

Online schools present an equity issue when schools rely on parents to provide support as part of the virtual school model. It is unclear how VPA plans to meet the needs of student who have less support at home. During the capacity interview, founders were unable to describe how students would be monitored during asynchronous time, therefore, the response was inadequate. The school schedule also raises questions about the amount of time students would have access to adults to support them.


<u>Career Technical Education</u>: The application is compelling in its mission and vision for supporting student career development but does not describe how the individualized internships and/or partnership and training would be actualized across the state. Founders did not present a regional plan to manage the relationship building to support for the CTE program when asked during the input hearing. Concerns arose over student safety when participating remotely in CTE courses, either alone or without a certified teacher in place. How the school would manage and ensure background checks for any adults that have contact with students, as required, is not clear. <u>Curriculum</u>: The application describes using Courses that are curated primarily from five curriculum providers: AMP for Education, Accelerate Education, StrongMind, eDynamic Learning, and FlexPoint. The applicant team describes them as "the best" but provides no evidence of quality, or alignment to standards, such as an Ed Report. The New Mexico Social Studies content standards were recently released, have these companies conducted an alignment study?

<u>Special Education and English Learners</u>: It is unclear how VPA will adequately address the needs of students identified as English Learners and those with IEPs, especially students with the most significant cognitive disabilities (MSCD). Students identified under the legal definition of MSCD would need to be assessed for support such as "extensive, direct individualized instruction" as well as "participation in alternate assessments" (Office of General Counsel, Special Education Division, June 2023). VPA has failed to create an adequate plan for these students.

<u>MLSS:</u> VPA presents an MLSS chart on p.35 deviates from PED initiatives and does not sufficiently address New Mexico's statute on the response to intervention process (<u>NMSA 22-13-32</u>). The PED utilizes the New Mexico Multi-Layered System of Supports (<u>MLSS Manual</u>, 2021), which demonstrates a stronger response to intervention program that offers more specific, comprehensive interventions and supports.

<u>Student/Teacher and Counselor Ratios</u>: VPA's ratios are concerning, even though during the input hearing founders suggested they would change class sizes, a 300:1 counselor ratio does not meet standard and raises the question of whether this school could deliver on its promise to individualize and support student success.

<u>Assessment Plan</u>: Left out of the assessment plan is a realistic picture of how the school would test students, in accordance with state-wide testing requirements. The budget does not include funds to rent facilities nor pay proctors and/or student transportation to testing sites. A 2022 report (GAO-22-104444) cites low student participation rates in state testing and problems in measuring student attendance as chronic issues in online charter schools. In a review of 2021-22 participation and proficiency data, PED discovered that across the state students in remote learning environments had lower test participation rates and lower proficiency rates overall.



<u>Staff Roles</u>: Staffing plans in the application also fell short in providing job descriptions for key staff members for this work. Additionally, a Student Success Team is referenced in the

application, but who sits on the team is never clarified and none of the staff job descriptions make mention of that responsibility.

<u>Business management</u>: It is unclear how the school plans to secure a school business manager and the expected role of the governing board treasurer. The confusion was demonstrated in the application (p. 83).

<u>ACCEL</u>: The application references a partnership with ACCEL Schools, a charter management organization (CMO), designed to make a profit from education. Online research suggest ACCEL is the nation's fourth largest and fastest growing for-profit chain, with sweeps contracts (an arrangement in which a charter school turns over all or nearly all its public funding to an operator who then runs the school) that give control and decision-making power over governing boards. One such contract with an Ohio charter can be viewed <u>here</u>.

<u>Community Need</u>: Although the founders appear genuinely concerned about improving the quality of education in New Mexico, they don't provide evidence of understanding the landscape of virtual education across the state. Most of the supporters spoke in favor of online education generally and were not necessarily prospective students/families. At the time of the input hearing the two existing online charter schools were still accepting applications to reach their enrollment capacity (one with 400 seats open, the other 160), and this doesn't account for the many other locally operated online programs run by districts and charters, nor the hybrid models that allow for more direct support to students.

Summary of Community Input Hearing and Support/Opposition

VPA's Community Input Hearing took place online and on the campus of Eastern New Mexico University on Wednesday, July 12, 2023. Fifty-six (56) people were in attendance, fourteen (14) person and forty-tow (42) online. Thirteen (13) people signed up to speak; twelve (12) spoke in favor; one (1) spoke in opposition.

The transcripts from the hearing were not published at the time this report was due, however CSD noted those in favor spoke about the value of having an online option, school choice and firsthand experience in an online educational experience. Workforce development and flexibility were also touted as the potential benefits of the school. Those in opposition to the charter mentioned there are already two statewide virtual schools, that CTE would be difficult to do online, and that not all students thrive in an online environment. A principal from the Portales school district spoke in opposition to the charter.

Results from the Google form show sixty (60) individuals support the school and four (4) oppose.

They have an opportunity to attend live lessons with their teachers daily, me included, to work directly on their IEP goals and to set them up for success after high school.

I can also attest to the parent-teacher relationship. In our virtual setting, the teacher communicates with the parent several times a week. It becomes a collaborative effort as the parent can work closely with the teacher to ensure that their student succeeds. It is not uncommon for a teacher to speak with a parent several times a week either through email, text, or phone. We have an opportunity to get to know our families personally and develop an excellent working relationship as well.

I believe every student has a unique learning style and the mission of Virtual Preparatory Academy is to reach all students with an individualized, career-focused education in an interactive learning environment rooted in rigor and innovation. VPA will reach students from across the state and provide them with an education that is tailored to their needs and learning style.
