

PEC Authorized School Report Overview

- Six schools are missing one or more of the required board officers.
- Thirty school boards completed all their required training hours.
- Nineteen schools earned a two-hour training exemption in Fiscal Understanding.
- · Please note that next year's Fiscal exemption will only be one hour.
- Three schools each had one board member who did not complete any board hours the
 past two years in a row and two schools each had one member with no board training
 the past three years in a row
- Fourteen newly appointed board members from nine different schools did not complete the required New Member Introductory Course.
- · Twenty-five board members from nineteen different schools did not complete any hours.
- Some of those members resigned.

The training can count for up to three hours of board training.










Promoting Onboarding
