
## **About the School**

New Mexico School for the Arts (NMSA) is a statewide residential charter school serving grades 9-12, with a total enrollment of 302, offering intensive pre-professional instruction in creative writing ant the performing and visual arts combined with a strong academic program that leads to a New Mexico diploma of excellence. The school is in Santa Fe; however, must serve and house (if necessary) students from around the state. Accordingly, the school has special requirements that it must meet yearly to remain in existence (6.80.4.17 NM Administrative Code). The school has a relationship with the non-profit organization, New Mexico School for


the Arts—Art Institute of which the primary purpose is to provide financial support to the school or leases the facility for the charter school.

NMSA offers students a rigorous mastery of the arts curriculum as well as an academic high school education. Admissions criteria are based on a student's passion, promise, and aptitude in the arts and it is the intent of the school to admit an equal number of students from each of the state's congressional districts. The school conducts outreach activities to acquaint all New Mexico students with the program. When necessary, room and board is provided for students who are not based in Santa Fe or the immediate surrounding areas. NMSA finds its own funding for outreach and for students' room and board if they are unable to pay.

The school intends that graduates will pursue post-secondary learning or a career in the arts and will contribute to society after completing the academic graduation requirements as well as the requirements of either of the five art disciplines offered: Creative Writing and Literature, Dance, Music, Theater, and Visual Arts. Students complete their academic day and then engage in intensive pre-professional instruction in the discipline of their choice. The school implements a Guest Artist program to augment students' technical skills, to offer real-life examples of how artists work in society, and to show students all that can be achieved in the pursuit of art.

## State Accountability System

The New Mexico State Accountability System gives every public school in the state an overall score. The top 25% of schools are designated Spotlight schools.

Schools were ranked by percentile within school type, with high schools being ranked separately from elementary and middle schools because of differences in how points are

calculated (e.g., graduation factoring into high school but not elementary school accountability).

Schools below the 75th percentile are designated either a Traditional Support School or are given one of several designations indicating a need for greater support:

- Targeted Support and Improvement (TSI): Public Schools (Title I and non-Title I) with one or more student groups that meet the state's definition of consistently underperforming
- Additional Targeted Support and Improvement (ATSI): Public Schools (Title I) with one or more student groups performing as poorly as the lowest performing 5 percent of Title I schools identified for CSI
- Comprehensive Support and Improvement (CSI) Student Group: Title I schools that were previously identified for additional targeted support and improvement and that did not meet the statewide criteria for exiting ATSI status within the number of years determined by the state
- CSI Graduation Rate: All public high schools in the state (Title I) with a four-year graduation rate below 66.67% for at least two out of the past three years
- CSI Low Performing: Schools scoring in the bottom 5% of all Title I schools
- More Rigorous Intervention (MRI): If a CSI School does not satisfy exit criteria within the identification cycle, they are identified as MRI.

**New Mexico School for the Arts** ranked above **89.4%** of high schools statewide. The school received a designation of **Spotlight school**.

## Proficiency

In prior years, Early Literacy (ELIT) data from the Istation assessment administered to grades K-2 was aggregated into an overall reading proficiency score. In 2021-22, Istation data are provided as a separate metric (ELIT). Only schools that serve grades K-2 will include ELIT data.

Because science is assessed only in grades 5, 8, and 11, schools that do not serve these grades have no science proficiency data.





### **High School Graduation**


