The New Mexico Public School Facilities Authority (PSFA) has received and reviewed the Facilities Master Plan/Educational Specifications 2023-2028 (FMP/Ed Specs) for Sierra County Community Charter School (SCCCS). The FMP/Ed Specs guide you in the planning and/or selection of a facility to ensure that it adequately accommodates your educational program and supports your method of instruction. Based upon our review, PSFA is pleased to announce that the FMP/Ed Specs meet our requirements for applicant charter schools and approves the plan. Your next step is to include your FMP/Ed Specs along with this letter in your charter school application to the New Mexico Public Education Commission (PEC).

In reviewing the SCCCS FMP/Ed Specs, PSFA understands:

- Sierra County Community Charter School seeks to begin operation in the Truth or Consequences community.
- Sierra County Community Charter School proposes an enrollment cap of 196 students in grades K-8.
- The school will phase its enrollment beginning with kindergarten through 6th until it reaches its full 196-student enrollment cap within five years.
- The school has considered several options for a potential facility and is focusing on three options. Each of the options will need some sort of renovation to accommodate students particularly in restrooms and outdoor learning/play areas.
- The school's preferred facility option is a City of Truth or Consequences owned building at 601 Sunset Street (Gardner Center). The school has five 500 square foot (SF) code compliant classrooms. The building also has a 2,500 SF unfinished space. The site this building sits on consists of 23 acres, which provides room for expansion.
- The two other options the school is considering include a building at 122 North Broadway (the Club), which could accommodate the middle school and a vacant building at 855 Van Patten.

- While the school desires the elementary and middle school students at one location, it will most likely need two facilities based on available space.
- The school's educational model takes a multi-pronged approach that focuses on the individual learner, project based learning, service, outdoor learning, and re-engaging students who have not returned to school as a result of the COVID pandemic.
- To deliver its educational program, the school proposes the following spaces:
 - o 5 K-5th grade classrooms
 - o 2 6th-8th grade classrooms
 - o OT/PT/SLP space
 - o Indoor physical education space for elementary students
 - o Administration space
 - o Media center space
 - Non-commercial warming kitchen
 - o Storage
 - Outdoor learning areas/playfields
- The school hopes to contract with the Truth or Consequences School District for meals but if it cannot enter into an agreement, there are other options available in the community.
- The school will deliver its art/music curriculum in the elementary classroom homerooms. The 6th-8th students will use project and auditorium space at the Club building.
- For 6th-8th media center, the Club location has a branch library and computer lab the students could potentially use.

If you are a successful applicant, please let PSFA know so we can update our database. In addition, if you are successful, this FMP/Ed Specs becomes the school's master plan over the next five years. Please do not hesitate to reach out if you have any questions or desire additional information.
