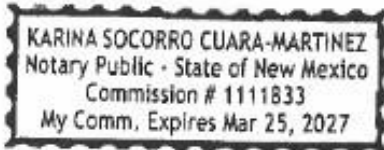

For students under the age of 18 living with a parent or guardian, the signature shall be the parent or guardian's signature. Petitions may be signed electronically but must include the student name(s), parent name, email address, and date.
