Hello Dep Sec DeBell and Director Peacock-Villada,

Thanks for your continued support and partnership.

Paola, the CSD team has requested the following data information to support the work of the PEC. I don't think that they have received the information yet and wanted to see if you could help us. We are working with this school to ensure that they are in compliance with their charter contract and making the gains needed for their students. Please let me know if you have any questions or need additional information.

The GREAT Academy (TGA), a state charter school, has in its contract a condition of renewal regarding graduation rates for schools with similar demographics to TGA. CSD has the 4-year (2021), 5-year (2020) and 6-year (2019) graduation rates for the comparison schools, but would like to have the aggregated graduation rates for a) the seven comparison schools as a group, and the aggregated rates for six of the schools (with the largest school, which will skew the average) removed.

The 7 comparison schools (all charters, with authorizer noted in parentheses) are:

- Cesar Chavez Community School (PEC)
- Mission Achievement and Success Charter School (PEC)
- Health Leadership HS (APS)
- Mark Armijo Academy (APS)
- New America School NM (APS)
- Robert F. Kennedy Charter School (APS)
- South Valley Academy (APS)

We would like average rates for these 7 schools and for 6 of them excluding Mission, Achievement and Success.
