As you heard this morning, the PED is releasing 2022-23 proficiency and growth data at 5 pm today. PED's Research, Evaluation and Accountability (REA) Division has provided CSD with an embargoed data file so that we were able to include these data in the attached Preliminary Renewal Analysis and Recommendation.

Please note that the accountability calculations that REA has provided to CSD do not match the vendor-provided files that LEAs have because the vendors do not prepare the All-Valid Test file that REA provides to LEAs. The proficiency and growth data in the preliminary renewal reports are the ones that will be released in Vistas today. The reports do not contain overall Vistas scores, as these were not available to CSD, or Cohort 2022 graduation data, as CSD was advised that that graduation data on the PED website will be taken down and corrected. CSD will include graduation data in the Final Renewal Analysis if it has been corrected and made public by December 1.
