

All Valid Enrollments (AVE)

 Universe of enrollments for all students (Pre-kindergarten to grade 12), schools, and districts in the New Mexico Public School system during the school year

Inclusion:

- ✓ All NM Public Schools/Locations including District #s 1-89, State Charters), New School for the Blind and Visually Impaired (#93) and New Mexico School for the Deaf (#94)
- ✓ Location #993 (Hospitalized), #994 (Off-site), and #998 (Homebound) are recoded and reported as #000 (District Office)

• Exclusion:

- ✓ Location #992 (Off-site Early Childhood Programs), #997 (Private Schools), and #999 (Home Schools)
- ✓ State-supported District #91 (NM Corrections), #95 (UNM MIMBRES), #97 (Sequoyah), and #99 (Juvenile Justice Centers)

- <u>PED Data Mart</u>: SY2023 Student Snapshots, including 1st, 2nd, 3rd, and 4th reporting periods
- <u>STARS reports</u>: SY2023 attendance reports for 1st, 2nd, 3rd, and 4th reporting periods

Definitions and Coding of Various Variables

- School number = (District number* 1000) + Location ID
- School days enrolled— sum of the total number of school days a student is enrolled in a given school/location during the school year
- District days enrolled- after applicable exclusions (schools), sum of the total number of school days a student is enrolled in a given district during the school year
- State days enrolled- after applicable exclusions (schools and districts), sum of the total number of school days a student is enrolled in the New Mexico Public School system during the school year
- Eligible indicates whether student is eligible for inclusion in calculations/reporting -- Students are eligible if enrolled 10 of more days in the New Mexico Public School system)
- Participation denominator and school indicates the school where a student was enrolled on both the 3rd and 4th snapshot dates
- Accountable entity includes the school district where the student was enrolled the longest during the current school
 year. Note: the accountable state is always "New Mexico"
- Eligible (version 2) student was enrolled 90 days or more at the Accountable (majority) School during the SY

Definitions and Coding of Demographic Subgroups

Subgroup	How to Code?
2.Female	Female students
3.Male	Male students
4.Hispanic	Students who are Hispanic
5.White	White students; Caucasian in Race1 variable, Race2 variable is empty/missing
6.Black	Black students; Black/African American in Race1 variable, Race2 variable is empty/missing
7.Asian	Asian students; Asian, Native Hawaiian, or other Pacific Islander in Race1 variable, Race2 variable is empty/missing
8. Native	Native students; American Indian or Alaskan Native in Race1 variable, Race2 is empty/missing
9.Multi	Multirace students; values in both Race1 and Race2 variables
10.FRL	Students who qualify for free or reduced lunch
11.NotFRL	Students who do not qualify for FRL
12.DirCert	Students with direct certification for SNAP or related benefits
13.NotDirCert	Students not certified to receive SNAP or related benefits
14.SwD	Students with disabilities
15.NotSwD	Students without disabilities
16.EL	English Learners
17.NotEL	Students not identified as English Learners
18.Migrant	Migrant students; data for this variable were obtained through PED Title 1 Bureau (not STARS)
19.Homeless	Homeless students
20.Military	Students with a parent in the military, including active duty, National Guard, and Reserves
21.Foster	Students with foster placement; data for this variable were obtained through PED (not STARS)

Business Rules

- All enrollment records and locations that are active on the snapshot dates (e.g., the 1st, 2nd, 3rd, and 4th reporting periods).
 - Inclusion/Exclusion include when a student is reported as enrolled in more than one school on the same snapshot date, the record where the student was enrolled the longest during the reporting period is used and the other excluded; and if the student was enrolled for the same number of days use the location where the student was enrolled during the next subsequent snapshot during the school year and the other record is excluded
- If a student's attendance records were not reported in STARS during the school year, or if the sum total number of days enrolled is less than 10 for all locations, the student is coded ineligible

Business Rules, cont.

• Priority in assigning student characteristics among multiple snapshots is as follows:

Most Recent	"If Ever" (present at any of the 4 snapshot dates)	Prioritize 3 rd , 2 nd , 1 st and then 4 th reporting periods	N/A
Student names Birthdate Gender Hispanic Race Military Years in U.S. Schools Plan 504	Free or Reduced Lunch Direct Certification Special Education English Learner Homeless	Grade Level	Migrant Foster
