Reed Weimer was elected to one of the available seats by the parents of enrolled students at Red River Valley Charter School and staff employed by Red River Valley Charter School. Voting ended at 4:00 PM on September 21, and the votes were counted by Mrs. Ritterhouse and witnessed by Tonya Lewis. Heather Larson, treasurer of the Governance Council, verified the votes.

On October 16, Nick Church was appointed to the vacant seat.
