

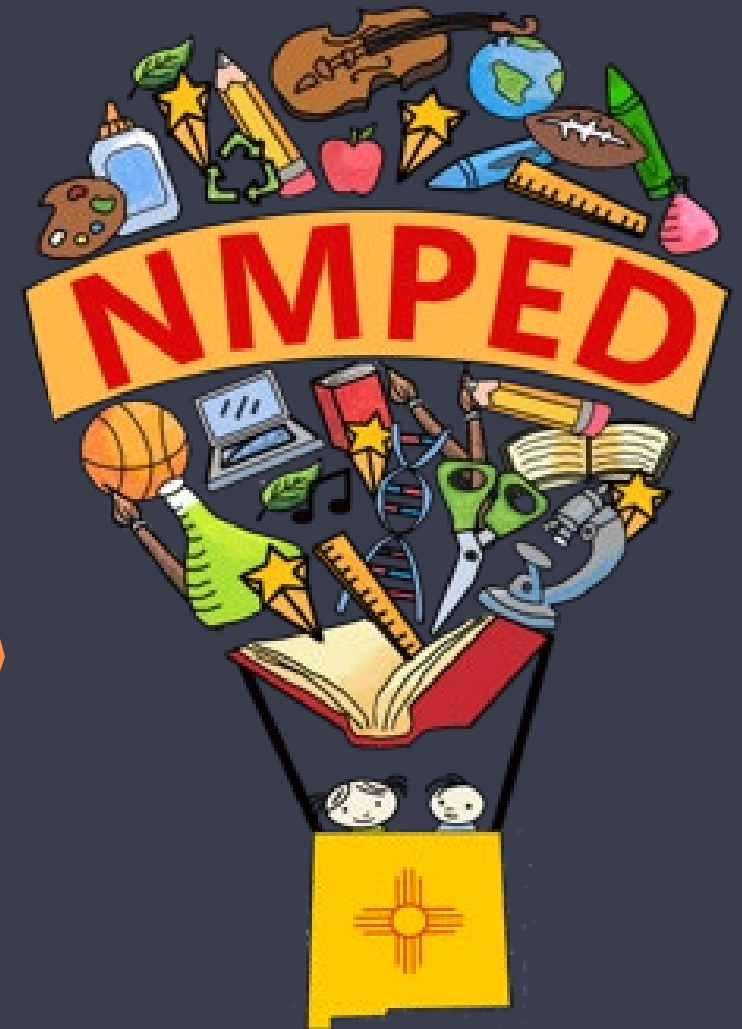

# Calculation of Infraction Rates

$$\textit{Infraction Rate} = \frac{\textit{Total number of infractions}}{\textit{Total number of students}} \times 100$$

- The infraction rate provides the number of infractions per 100 students
- A student may be involved in more than one infraction, so the numerator may include a student more than once if involved in multiple infractions

# Chronic Absenteeism (%)

- Definition: Percentage of students absent (including excused and unexcused) 10% or more of school days enrolled
  - For detailed inclusion and exclusion criteria, please refer to All Valid Enrollments guide
    - ✓ Other factors affecting inclusion / exclusion include
      - Inclusion: Students with valid enrollment records in the New Mexico Public School System including at least 10 days during the school year as identified in the “All Valid Enrollments” (AVE) file
      - Exclusion: Schools not identified on the list of New Mexico Public Schools to be included in Accountability System (except District Offices)
- If a student’s attendance records were not reported in STARS during the school year, or if the sum of the total number of days enrolled is less than 10 for all locations, the student is excluded from calculations



# Data Sources

- STARS Reports

- The following two attendance reports for SY2023 at the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> reporting periods, otherwise referenced as “40 day”, “80 day”, “120 day”, and “End of Year” (including 8 reports total) are used:

  - ✓ [Summary Attendance No Snapshot Report SY21-22 - Present \(Part 2 of 2\) \(NEW\)](#)
- SY 2023 All Valid Enrollments (AVE) file, *“Vistas SY 2022-23, AVE, COMPREHENSIVE with AnyNative AnyBlack exclude Ineligible students, V20231215 KF”*
- PED SY2023 Entities File including Title 1 schools, *“Vistas SY 2022-23, Title Schools List Matched with REA List V.2023.11.06”*
- Variable Names/Measures include:
  - ✓ “STUDENT\_ID” = Student ID
  - ✓ “District\_Code” = LEA code
  - ✓ “Location\_ID” = Location ID
  - ✓ “DAYS\_ENROLLED” = Number of school days enrolled during the reporting period at a given location
  - ✓ “DAYS\_PRESENT” = Number of school days present during the reporting period at a given location

# Formula and Calculations

- Chronic Absenteeism (%) = number of chronically absent students (including excused and unexcused absences) / total number of eligible students
- Chronic Absenteeism (%):
  - *Number of students enrolled* = sum of the total number of students enrolled at a given school / location during the school year
  - *Number of chronically absent students* = sum of the total number of chronically absent students enrolled at a given school / location during the school year
  - *School Chronic Absenteeism (%) = Number of chronically absent students / Number of students enrolled*
